Call to Order-Introductions

Discussion:

Everyone introduced themselves.

Minutes of the June 29 Meeting

Discussion:

Dr. Vermeer motioned to approve the QCEPC June 29, 2018 meeting minutes and Gayle Lundeen seconded, the motion passed.

Homeland Security/EMA/IMT Reports

Discussion:

Brian Payne shared they have been working on developing materials for Medicare facilities to assist them in meeting their CMS requirements. They are currently planning an exercise in the EOC with Exelon in December to meet their Bi-Annual Evaluation with FEMA. Once the date in December has been established, Dave will disseminate.

John Showalter reminded the group the Area Maritime five-year assessment will be August 8th, 9th and 10th. They will be looking at critical infrastructure up and down the river from Muscatine to Clinton.

Dan Howard reported Clinton County has been providing Run, Hide, Fight and Stop the Bleed training.

Scott Starnes shared Colonel Stephen Marr took command of the U.S. Army Garrison Rock Island Arsenal. Relinquishing command was Colonel Kenneth Tauke. Scott reminded the group their next installation protection full-scale exercise is planned for May 8, 2019. The Arsenal is moving to a two-year cycle.

Jerry Shirk asked as the group attends conferences to keep the Quad Cities Readiness Conference in mind and forward any dynamic, pertinent possible speaker contact information to him or one of the committee members.

Communications Center Updates-Radio Study

Discussion:

Denise Pavlik reported Elert gave a summary presentation of proposals received from Motorola and RACOM/Harris Corporation on July 24th with a technical discussion of both proposals and questions and answers opportunity. On July 25th, a financial discussion of both proposals with next steps in the process discussion was held. Both sessions were open to the public. The July 30th joint board meeting of RI ETSB and SECC will be rescheduled to a future date, as there are many details to consider. Decker Ploehn thanked Denise Pavlik for her dedicated leadership with the project.

Denise asked anyone coming to the SECC building the week of July 30th not to park in front of the building. A construction company will be concreting the twelve spaces to the South.

BIX/RAGBRAI

Discussion:

Brian Payne reported the mobile command unit will be onsite at the BIX/RAGBRAI. Major Jeff Bladel reminded the group to watch social media for route and parking updates. Al Loeffelholz shared he receives hospital updates on the RAGBRAI daily which he has been sharing with MEDIC.

Healthcare Coalition Updates

Discussion:

Al Loeffelholz reported the Coalition will be supporting the Iowa Trauma Conference by providing funds to two people from each agency to attend. A new partner conference call explaining fiscal and documentation requirements of the PHEP grant will take place on August 8th.

Other Hospital-Healthcare Reports

Discussion:

Kate Meyer shared the Rock Island County Health Department is assisting Illinois residents with applications for state medical cannabis cards. It is a multi-step process that includes a physical examination; the doctor must certify the patient has at least one of the qualifying medical conditions and fingerprinting to obtain a card.

Denny Coon reported a Stop the Bleed training will be done at the Scott County Health Department All-Staff meeting on August 20th. Denny shared three staff members participated in the Real Location drill at North Scott High School.

Al Loeffelholz reported Genesis East will be doing an Exelon drill on October 31st. The TEDCON (Trauma, Emergency, Disaster) conference will be August 23rd and 24th in Peoria, IL. Lastly, September 19th they will be participating in the 3M Active Shooter exercise.

EMS Reports-Lay Person Narcan Administration

Discussion:

Kevin Lange reported at their last joint meeting they were able to hand out the Stop the Bleed kits and tourniquets purchased through the 5A Coalition to the agencies. They have been able to distribute Stop the Bleed kits to all the Scott County Schools to place with their AED's as well. Lastly, they will be distributing Stop the Bleed Kits to Bettendorf, Davenport and Scott County law enforcement agencies.

Kevin shared discussion was held on the QC Harm Reduction organization. The organization educates and hands out Narcan. There will be a Quad Cities Harm Reduction Awareness Walk on August 25th.

Al Loeffelholz shared through 5A Collation and Genesis funds they have printed banners and posters to distribute throughout their campuses to educate and create an awareness for their patients and families of OPIOID addiction.

Mack Parker added that it is important to carry Narcan and train agencies personnel to protect themselves, as one would only need to encounter a microscopic amount of Fentanyl to need assistance.

Decker suggested Narcan Administration/OPIOID Addiction remain as an agenda item.

Bethaney Conklin reported the Region 5A EMS meeting will be held at Johnson County EMA August 23rd at 3:15 pm to 5:15 pm. It is requested that each County have an EMA representative.
