# Homeland Security/EMA/IMT Reports

#### Discussion:

Jerry Shirk distributed a Community Planning for Disaster Recovery course being held at the Rock Island County EOC on October 17, 2018. Modules included in the course are: Introduction to Disaster Recovery Planning, Partners in Disaster Recovery, Disaster Recovery Plan Elements and Disaster Recovery Plan Development.

Scott Starns reported there will be a working group meeting in October to begin planning their May 2019 exercise.

Dave Donovan shared they have been working on credentialing policies for Salamander. Dave noted the Coast Guard Assessment went well and thanked the participants.

Chance Kness updated the group on the following conferences and training opportunities:

- Incident Command System and Resource Management for the Fire Service Course: October 18-19, 2018 at the Clinton Community College Technology Center. This course meets the requirements of ICS-100 and ICS-200.
- Understanding Implicit Bias for Law Enforcement and Justice Administration:
   September 18, 2018 at the Clinton County Satellite Office Conference Room, DeWitt. The cultural diversity training on understanding implicit bias emphasizes that even well-intentioned people have implicit biases that can influence their actions, that recognizing those biases are key in learning how to override them, and that policing bases on biases can be unsafe, ineffective and unjust.
- 2018 Iowa Homeland Security Conference: October 4-5, 2018 at the Union Memorial Hall on the University of Iowa campus.
- International Association of Emergency Managers Conference: Grand Rapids, Michigan. There will be pre-conference training opportunities October 18-20, 2018 with the Conference being held October 21-24, 2018.

Quad Cities Local Emergency Planning Committee (Scott County IA and Rock Island County IL)	

#### Discussion:

Shirk called the Quad City Local Emergency Planning Committee meeting to order at 9:40 a.m. as a continuation of the Quad City Emergency Planning Committee that began at 8:30am. Introductions were made during the QCEPC portion of the meeting. Sign in sheet was distributed to document those present. Linda Frederickson moved and Jerry Ewers seconded to approve the minutes from the May 25, 2018 QCLEPC meeting. All ayes.

Donovan and Shirk discussed the status of the merged QCLEPC. Apparently there was some confusion with the State of Illinois, which has now been clarified and resolved. Donovan suggested that we just include LEPC items each month rather than quarterly, which will make the meeting minutes and agendas easier to manage. That will begin next month.

Donovan gave a training update which included two LEPC courses: Whole Community Planning on Nov. 1 and On-Scene Crisis Leadership on Nov. 2. Both courses are listed on the Iowa Homeland Security training website.

Donovan reviewed annual updates to the Scott County ESF-10 Hazardous Materials plan. Ewers indicated that he felt the plan was thorough and complete. Ewers moved to adopt that plan. Conklin seconded. All Aves.

Donovan and Melton reported that the Scott County Multi-Jurisdictional Hazard Mitigation Plan had been approved by FEMA after revisions. Some municipalities and school districts still need to adopt.

Donovan reported that the Scott County Commodity Flow study has been received in draft. Revisions are underway. Final document should be available in September.

Reviewed several exercise initiatives in progress or in planning.

Representatives from the cities of Walcott, Blue Grass and Scott County (Kostichek, Koehler and Kinzer) discussed their concerns with weather warnings and sirens for their communities. Representative from

National Weather Service (Gibbs) discussed their processes. Donovan explained current siren guidelines for QCA and state-wide best practices. Pavlik explained SECC processes. After much discussion, a plan was devised to move the issue forward and to begin to address concerns. Plan contains new strategies for weather spotters, early alerts and public education.
