Homeland Security/EMA/IMT Reports

Discussion:

Jerry Shirk introduced Sergeant Mindy Meyers. Mindy is working at the EMA office fulltime. Jerry shared a COAD workshop will be held October 9, 2018, Executive PIO group meeting October 11, 2018 and a Community Planning for Disaster Recovery course October 17, 2018.

Brian Payne reported they continue to organize tabletop exercises with the schools and developing materials for Medicare facilities to assist them in meeting their CMS requirements. Brian shared they are beginning to reengage the PIO group within the larger public entities in effort to align PIO goals and objectives and be prepared to respond to large scale emergency situations.

Dan Howard shared the Ground Search Class is scheduled for October 27, 2018.

Communications Center Updates

Discussion:

Denise Pavlik reported through a collaborative and thorough process it was the formal recommendation of the Radio Committee that the proposal provided by RACOM be accepted by the SECC and Rock Island ETSB Boards. On September 27, 2018, the SECC and Rock Island ETSB Boards voted to accept the proposal from RACOM for a new P25 Radio System during a Joint Board Meeting. The next step will be contract negotiations.

Healthcare Coalition Updates

Bethaney Conklin discussed the talking points from the last Region 5A meeting. She reported a Salamander Overview will be held at the Johnson County EMA on October 25, 2018. Bethaney will be sending a survey out to see if anyone is still in need of Stop the Bleed kits in the area. Bethaney shared she is working to buy AHA compliant CPR mannequins with Mission Lifeline funds for agencies in the area.

Other Hospital. Healthcare Reports

Discussion:

Andrea Bladel reported Genesis will be participating in IHA's program to give free Narcan kits to those individuals that are leaving the ER that may be at high risk for a drug overdose.

Denny Coon shared the Health Department Accreditation Site visit took place September 13, 2018 and September 14, 2018. The visit went very well. The Public Health Accreditation Board (PHAB) specialist stated the Department should be on the agenda for the November 20, 2018 PHAB Accreditation Committee. Within two weeks of the meeting, the Department will be notified whether it has been granted accreditation status or placed on an action plan.

EMS Reports

Kevin Lange reported there are three Stop the Bleed kits available for training purposes. Anyone that would like to schedule to use the training kits should contact Kevin. Kevin shared they have received funds from the System Development Grant. A Plan of Action Spending Plan is due mid-October on how the funds will be used.

Chris Varnes shared Region 5A will be purchasing Children Have An iDentitiy (CHAD) stickers. The stickers can aid in identifying children involved in traffic crashes. The sticker is placed on the car seat.
