Discussion:

Everyone introduced themselves.

Minutes of the September 28th Meeting

Discussion:

Dave Donovan motioned to approve the QCEPC September 28, 2018 meeting minutes and Chuck Gipson seconded, the motion passed.

#### Homeland Security/EMA/IMT Reports

#### Discussion:

Dave Donovan shared the Exelon Nuclear Power Plant non-evaluated exercise is scheduled for October 30, 2018 with the evaluated exercise planned for December 4, 2018. Scott County EMA is continuing to organize tabletop exercises with school districts and developing materials for Medicare facilities to assist them in meeting their CMS requirements.

Jerry Shirk reported the Executive PIO group met on October 11, 2018. Jerry shared Brian Payne will begin taking the lead on the IMT group with a focus of reinvigorating the IMT.

Chance Kness reported Clinton County EMA is hosting a Ground Search Class for first responders and CERT team members at Eagle Point Park, Clinton on October 27, 2018. A tabletop exercise is planned with Central Dewitt Schools on November 6<sup>th</sup> with a large-scale active shooter exercise being planned for January.

Scott Starns shared they will be switching from their current mass warning notification system to the Alerts system over the next year.

#### **OCLEPC:** Training, Planning, Exercise

#### Discussion:

Dave Donovan reported they will be hosting an Iowa Homeland Security Class, Building Whole Community Engagement through Local Emergency Planning Committees (LEPC) on November 1, 2018. They are considering planning a Hazmat tabletop exercise over the winter. Scott County Secondary Roads is hosting a Roadway Safety Plan meeting on October 29, 2018 focusing on the five E's of safety: Engineering, Education, Enforcement, Emergency response, and Everyone.

#### **Communication Center Updates**

#### Discussion:

Denise Pavlik reported the proposal from RACOM for the new P25 Radio System was accepted and contract negotiations will be beginning.

#### Discussion:

Decker noted the QCRDPC Planning Committee will meet following the QCEPC meeting.

#### Healthcare Coalition Updates

#### Discussion:

Chris Varnes shared Region 5A has purchased Children Have An iDentitiy (CHAD) stickers. The stickers can aid in identifying children involved in traffic crashes. The sticker is placed on the car seat. Anyone needing stickers should contact Chris.

Bethaney Conklin shared the Health Sector Emergency Preparedness course will be offered November 5, 2018 at SECC, which is a valuable course for any public or private sectors that must comply with CMS rules. Bethaney updated the group on additional upcoming training opportunities within the grant with more information coming.

Bethaney reported representatives from Salamander were at the last Region 5A meeting sharing capabilities of the system after the new upgrade. Dave Donovan reported progress is being made in the Quad City wide initiative enrolling community responders in the Salamander system.

#### Other Hospital/Healthcare Reports

#### Discussion:

Dennis Frisch shared the Administrative Rule Chapter 132 – EMS Service Program Authorization is in the process of being rewrote. Dennis warned the proposed changes are very different from the current Rule and will affect EMS services, personnel, service directors and medical directors. He said they have been advised to compare the current Rule to the proposed rewrite.

Andrea Bladel reported Genesis Medical Center, Davenport is now a Level III Trauma Care Facility designated by the State of Iowa. Currently, Level I and II Trauma Care Facilities in the State of Iowa are required to be verified by the American College of Surgeons instead of Level II Trauma Care Facilities being designated by the state as was allowed since the inception of the trauma system in Iowa. Services provided at GMC- Davenport will remain the same as a Level II trauma care facility.

Patsy Willits shared they will be aiding in a drill with Monsanto/Bayer using a chlorine leak explosion with injuries scenario. Patsy reported their Public Health Department completed POD training.

Kate Meyer shared Nita Ludwig and her attended a POD Essentials train the trainer course in Alabama.

#### EMS Reports – QCA Opioid Crisis

#### Discussion:

Chuck Gipson shared the 2018 Trauma Conference: A-Z and Everything in Between will be held November 2, 2018 at the Waterfront Convention Center. The conference will educate emergency medical service professionals on the essential components involved in a variety of scenarios.

Chuck reported they are seeing a slight decrease in Naloxone usage.

Adam Haut shared he is taking over for Mark Guthrie at Genesis Ambulance.

Bethaney Conklin reported the EMS Collaboration Committee has voted to purchase eight adult and eight infant AHA compliant CPR mannequins with Mission Lifeline grant funds per participating county EMS association. Denny Coon added the individual EMS spending plans have been approved up to \$4700 per participating county EMS association. Locally the funds will be used to assist in supplementing EMS refresher course costs.
