## Approval of Minutes of the August 29, 2025, QCEPC Meeting

# Homeland Security/EMA/IMT/PIO Workshop

Isaias Martinez-Garza, Rock Island Arsenal, stated that Rocktoberfest will be held on Friday, September 26th at the Arsenal and there will be a wrestling ring, food, and music. Sunday there is a QC Marathon on the Arsenal. There will be a full-scale exercise first week of May 2026. Also, they will no longer do passes and will require your Real ID to access the Arsenal.

Brian Payne, Scott County EMA, stated that the impact of the flash flooding on July 11<sup>th</sup>, 2025, has our office looking at future options for the cities and other communities to put weather stations around Scott County pending grant. This will give insight on weather throughout Scott County to help us be better prepared for future events. Also, the AMSC meeting about a month ago and planning an exercise soon for a unified command and will "activate" the EOC for this exercise. Brian stated that he is officially going to roll out the program with Jelly Roll in October/November and dispatch him when he is called upon. Other community partners, like PD, etc., want to get their own Crisis Canine. The program is growing rapidly and they are doing amazing things. Also, a final draft was created of sub-areas of Scott County – during an emergency, it is easier to break the county down into sections (sub-areas) for situational awareness needs. Looking to schedule further meetings with partners to confirm these sub-areas and expecting it to be finalized soon. Lastly, the lowa DOT will be at next meeting.

### **Communications Center Updates**

Melissa Ketcham, SECC, stated that not much is going on, but they were notified of an anti-Trump rally Saturday, September 26<sup>th</sup>, at VanderVeer Park, so they are prepared for that.

Scott Ryckeghem, QCOMM, stated that they had a small administrative line phone issue that routed all jail traffic to the QCOMM network for about 30 minutes. They handled it, and there were no further issues. They are going through a hiring process and looking to fill 3 positions with interviews next week.

Kelly Thompson, Disaster Ready QC, stated they are handling any unmet needs by providing resources for people who were affected by the flash flooding. They are open to doing a presentation in the future to educate everyone and talk more about all the committees and roles people play in DRQC.
