#### **Case counts trending higher**

Remarks from Nita Ludwig, administrator, Rock Island County Health Department

We are seeing higher case counts in recent days, which could be associated with Labor Day gatherings. We have seen jumps in cases after every summer holiday this year.

If you believe you have been exposed or know that you attended a gathering without taking proper precautions, please get tested. There is a state-run testing site open 9 a.m. to 5 p.m. every day through Sunday at the QCCA Expo Center in Rock Island. Any Illinois resident regardless of symptoms can get a free test at the site. You may be asked to provide your insurance card.
