Following discussion, Dr. Garvin moved to approve and authorize the Director to sign the Summer Youth Feeding Program Contract. Motion seconded by Mrs. Coiner. Motion carried unanimously.

Dr. Garvin complimented Roma Taylor on two presentations she gave to the pediatric physicians on immunizations and on disease reporting.
