Dr. Keppy welcomed the Board of Supervisors to the Annual meeting. Jim Hancock introduced the rest of the board: Chris Gallin, Tom Sunderbruch, Larry Minard, and Roxanna Moritz. He wanted to recognize the Health Department employees, as well as all county employees, for doing such a great job.

Denny Coon and Amy Cannady presented to the Board regarding updates to the Scott County Health Department Public Health Preparedness Plan. Following discussion, Mrs. Coiner moved to approve the updates to the Scott County Health Department Public Health Preparedness Plan. Motion seconded by Dr. Garvin. Motion carried unanimously.

Dr. Lehman, member of the Tobacco Free QC Coalition, discussed possibilities to enlist local support for the FY'08 Legislation. Following discussion, Dr. O'Donnell moved that the Scott County Board of Health be in full support of the Tobacco Free QC Coalition proceeding with whatever measures needed to begin a community dialog. Motion seconded by Dr. Garvin. Motion carried unanimously.

Tom Newton director of the Iowa Department of Public Health, complimented Scott County on what a great job the Health Department does. They set the standard across the state.

He gave an orientation to the State Health Department. IDPH is organized into six divisions: Acute Disease Prevention & Emergency Response, Administrative & Professional Licensure, Behavioral Health, Environmental Health, Health Promotion & Chronic Disease Prevention, and Tobacco Use Prevention & Control. The four priority areas they will be working on over the next four years are wellness, co-existing disorders (mental health & substance abuse), preparedness, and Public Health Redesign.

There was some discussion regarding federal funding for jail based substance abuse treatment.
