Mrs. Coiner, Chairman, called the meeting to order at 12:05 pm. The Recording Secretary took the roll call. Mrs. Coiner and Dr. Hanson were present. Dr. Garvin arrived at 12:12 pm and Dr. O'Donnell arriving at 12:15 pm.

The following reports were reviewed and discussed by the Board:

1. Director's Report of December 2010 – January 2011 activities.

Edward Rivers reported:

- The Department will pilot an online payment process for the annual operational permits. We are hoping this will be successful as it could possibly inform a policy for the county.
- The state of Iowa instituted changes in how death certificates are to be completed in order to

collect more demographic information.

- The final inspections associated with the Department's contract with the Iowa Department of Inspections and Appeals were completed for 2010.
- The Immunization Audit results were reviewed with the Board.
- There has been discussion with both Tom Fedje and Tom Bowman about the provision of dental screening and fluoride varnishes in the WIC setting.
- Staff attended training for "Soil and Site Evaluation and Design of Onsite Wastewater Systems" sponsored by the Onsite Wastewater of Iowa Training Center.
- 2. Public Health Activity Report for the month of December 2010.

We continue to report Pertussis cases in the county but it seems to be leveling off.

3. Budget Report for the month of December 2010.

The committee is in the process of writing the metric of the Public Health Standards as well as revising the Standards for clarification. The state will put out an RFP for a Pilot Accreditation Process.

Following discussion, Dr. O'Donnell moved to approve and authorize the Director to sign the Memorandum of Agreement between the Iowa Infertility Prevention Project and Prevention Partners and Scott County Health Department for the purpose of collaborating to reduce STD related infertility. Motion seconded by Dr. Garvin. Motion carried unanimously.

Following discussion, Dr. O'Donnell moved to approve and authorize the Director to sign the Memorandum of Agreement between the Iowa Infertility Prevention Project and Prevention Partners and Scott County Correctional Health Services for the purpose of collaborating to reduce STD related infertility. Motion seconded by Dr. Garvin. Motion carried unanimously.
