## SCOTT COUNTY BOARD OF HEALTH October 20, 2016 MEETING MINUTES 12:01 p.m.

The meeting was called to order by Mrs. Coiner, Chair of the Scott County Board of Health.

Dr. Hanson moved to accept the agenda. Motion seconded by Dr. Sandeman. Motion carried unanimously.

Dr. Hanson moved to approve the minutes of the September 15, 2016 Board Meeting. Motion seconded by Dr. O'Donnell. Motion carried unanimously.

Edward Rivers also recognized a new employee, Katie DeLaRosa. She will serve as a Medical Assistant in the Clinical Services Area.

The following reports were reviewed and discussed by the Board:

## A. Director's Report

Edward Rivers informed the Board that staff investigated the report of a flood at the Best Value Inn. A sprinkler head in a room on the second floor malfunctioned and broke, causing the sprinklers to discharge. The renter did not inform anyone and left the building. The

water saturated all three floors of the hotel. The building owner has decided not to remediate the damaged hotel and it will be demolished.

Edward Rivers reported the Iowa Department of Public Health and Iowa Department of Inspections and Appeals are working together to change the process for reporting foodborne illnesses. In September, staff attended a webinar to discuss the plan for reporting and to learn about a new interview tool. In October, an Iowa "SIC" line will be promoted throughout the state. This number will be for the public to call to report suspected foodborne illnesses. Depending on the county, the caller will either be transferred to the local health department (how Scott County calls will be handled) or will be interviewed by IDPH students. Internally, our procedure will remain the same.

Edward Rivers informed the Board that staff met with Linn County Public Health (LCPH) staff to discuss the Electronic Health Records (EHR) System, Practice Fusion, which will be used for the STD clinic. The meeting was very beneficial. LCPH demonstrated how their clinic utilized the EHR. In addition, staff reviewed two options for initiating a new client visit, where to document past medical history, and how to query reports. The meeting afforded staff the opportunity to tweak the Scott County EHR, which will be presented to Health Department staff on October 11.

Mr. Rivers stated in the wake of current flooding in Iowa, staff assisted the Scott County Emergency Management Agency with creating a one-page flyer on septic systems, private water wells, and safety during flooding. The flyer provided tips on preparing for a flood, how to remain safe during flooding, and important steps to follow for flood clean-up. The flyers were distributed to residents living near the flood zone of the Wapsipinicon River. Staff also completed risk assessments related to the flooding as well as the tornado that passed through Scott County.

Mr. Rivers informed the Board that staff met to discuss a potential collaboration between United Neighbors and the Health Department when the County's lead poisoning initiative gets underway. United Neighbors is excited to engage in a more proactive approach to this avoidable public health crisis.

## D. Scott County Kids Report

Diane Martens informed the Board that the Department of Human Services (DHS) has increased the regulations for childcare homes and childcare centers. The Scott County Kids Board is grateful that the department's Child Care Nurse Consultant has willingly taken on providing the training required to meet the regulations.

E. Child Health Program, Local Public Health Services Program, Tobacco Use Prevention Program, and Women, Infants, and Children (WIC)/Breastfeeding Peer Counseling Program Report for the month of September 2016.

Tiffany Tjepkes informed the Board that Becky Nowachek, Regional Community Health Consultant with Iowa Department of Public Health, recently conducted a compliance review of the Local Public Health Services Program. Becky was pleased and complimented the department on a great job.

Tiffany reported that staff continues to work with the Iowa Department of Public Health and community partners to determine the needs in our community and to develop a plan as to how we move forward with the Maternal Health portion of this contract.

She also informed the Board that staff has been working to become familiar with the Dental Wellness Plan and the department's contractual responsibilities.
