Monitor Health Status

Communicable Disease Program

Thirteen communicable diseases were reported during November. They included four cases of hepatitis C, four cases of pertussis, two cases of campylobacteriosis, and one case each of hepatitis B, salmonellosis, and Dengue fever.

Rabies Risk Assessments

Twenty-three individuals required rabies risk assessments after exposures to sixteen dogs, seven cats, and one bat. Rabies post exposure prophylaxis was recommended for eight individuals.

Childhood Lead Poisoning Prevention Program

In November, there were fifteen children receiving individual case management. Of those, one had a blood lead level between 20-44 ug/dL and seven had a blood level between 15-19 ug/dL.

The remaining seven children had a blood lead level less than 15 ug/dL. Twenty-eight children with an initial blood lead level between 10-14 ug/dL were receiving supportive services (visual inspections, education over the telephone, appointment reminders) for lead poisoning this month. Of those, twenty-two had a blood lead level between 10-14 ug/dL and six had a blood lead level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 5 ug/dL are obtained.

Twelve children attending the Scott County Health Department's (SCHD) Immunization Clinic accepted lead testing services during their visit. Six children were between the ages of one and two years. Six children were between the ages of three and six years. There were no new positives identified from immunization clinic this month. Scott County WIC locations completed twenty-eight lead tests in the month of November. No new positives were identified during this effort.

Life Expectancy Data Project with Scott County GIS Staff

Staff met with Scott County Geographic Information System (GIS) staff during November to discuss a project related to mapping of life expectancy data for Scott County. The Centers for Disease Control and Prevention (CDC) recently released data sets through its U.S. Small-area Life Expectancy Estimates Project. The data provides this comparative measure for health based on census tracts. SCHD is investigating how this data can support our work on health equity. Conversations have begun with partners in Scott and Rock Island Counties to gauge interest in mapping Rock Island County life expectancy data and other data in order to gain a larger understanding of differences in health within the Quad Cities area.

Diagnose/Investigate Health Problems and Hazards

Sexually Transmitted Disease Program

One hundred and twenty-five clients received sexually transmitted disease (STD) clinic services during November. Fifteen clients tested positive for chlamydia, three tested positive for gonorrhea, and one tested positive for herpes at the Health Department's clinic. In total, ninety-five cases of chlamydia and thirty-nine cases of gonorrhea were reported in Scott County during the month.

Evaluate Effectiveness, Accessibility and Quality

First Med Pharmacy Review

In October, two hundred and forty-three inmates received one thousand one hundred and twenty-eight prescriptions. The use of generic medication was at ninety-seven percent.

Water Well Quality Improvement Project is Finalized

Staff facilitated a follow-up meeting with the Water Wells quality improvement team in an effort to review the water well sampling report, the quality improvement project timeline and tasks, and to decide whether the group wanted to standardize the change or develop a new

quality improvement timeline. The consensus of the group was to adopt the tasks to distribute the approved “Understanding Your Water Testing Report” document when necessary and to record in the Health Database. In addition, the group has made some revisions to the proposed budgeting for outcomes/performance measures for fiscal year 20 to capture our efforts rather than efforts we are unable to control.

Food Program Quality Assurance Inspections Completed

Staff completed quality assurance inspections for the food program. The quality assurance inspections are a component of the department’s efforts to ensure uniformity among the food program inspectors in interpretation and application of laws, regulations, policies and procedures by reviewing twenty quality assurance elements of our program. The quality assurance efforts are guided by the Food and Drug Administration’s (FDA) Voluntary National Retail Food Regulatory Program Standard Four.

Per contract with the Iowa Department of Inspections and Appeals (DIA), the department is required to meet standards two, three, four, six, and nine of the FDA Standards.

Documentation of our quality assurance inspections and process was submitted to DIA and the verification audit found that the department met standard four. We currently meet standards one through four. Standard six was submitted in March and is currently being audited. We have a quality improvement project scheduled for early 2019 to assist in meeting standard nine.

Develop Policies and Plans

Community Health Improvement Plan

Initial planning efforts are underway related to the 2018-2019 Scott County Community Health Improvement Plan (CHIP). SCHD will be partnering with Rock Island County Health Department in the CHIP process, which will include a series of community meetings to dive deeper into the three topic areas identified as top needs during the Community Health Assessment process: Mental Health; Nutrition, Physical Activity, and Weight; and Access to Healthcare Services. Community partners and front line staff are being identified to participate in each community meeting to inform the creation of goals, objectives, and strategies for the 2018-2019 CHIP.

Enforce Laws and Regulations

Iowa Department of Public Health Annual Report

The Fiscal Year 2018 Annual Report for Swimming Pool, Tanning and Tattoo Programs for Scott and Clinton County’s was submitted to the Iowa Department of Public Health (IDPH). This annual report is a requirement of the contract with IDPH to conduct the inspections. Staff conducted one hundred and nineteen inspections of public swimming pools and spas. One hundred and eleven of the inspections had at least one violation noted. The violations were typically related to documentation. Thirty-three tanning facility inspections were completed and six had violations. Twenty-seven tattoo facility inspections were completed and three had violations.

Animal Bite Reporting Discussion

Staff met with Scott County Attorney Rob Cusack and Lieutenant Kitty Schutts, Animal Control at Humane Society, to discuss improving animal bite reporting and quarantining of animals that bite or scratch people. The discussion was focused on issues related to one local animal rescue shelter. Staff will plan a meeting with the rescue director to discuss the state and local codes that are required to be followed when dealing with animal bite situations.

Update Regarding Cockroach Complaint in LeClaire

The owner of the property was notified of the Board of Health's November denial of her appeal of the notice and order. Since that time, she has been in regular contact with department staff about her progress toward getting the property cleaned up and getting rid of the cockroaches. An inspection was conducted on December 7, 2018, by staff. They only found one live cockroach in the basement. The house is nearly empty and no one is living there now. One of the two sheds on the property has been cleaned out, and the other one still has some personal items in it.

Hotel Inspections Completed

A component of the department's contract with DIA is for hotel inspections. While the DIA contract only requires pre-opening and complaint inspections, the department sees value in routine inspections and as a result inspects them on a bi-annual basis. Half of the hotels in the area are inspected each year. The half designated for 2018 have been inspected.

Bat Complaint at a Bettendorf Rental Property

Staff has been working on a bat complaint at a rental property in Bettendorf. A citation was issued to the owner for his failure to abate the bat infestation which was documented by a nuisance wildlife control company. During the process, it was discovered that the property was not registered as a rental property. It has since been inspected by Bettendorf Fire Department. Staff is working with the Fire Department on a resolution to the issues identified at this property. The Fire Department is also requiring the resolution of the bat infestation.

*Research for new insights and innovative solutions*AEDs at All Non-Public Schools

At the end of the 2017-2018 school year, two out of the nine non-public schools in Scott County reported they did not have an automatic external defibrillator (AED) in their school. Over the summer, staff researched AED's, examined multiple suppliers for the units, and investigated potential funding for the schools. In late October, Scott County Kids purchased one AED for each of the non-public schools without one. Staff delivered the units to the schools and helped school staff establish direct contact with the supplier so the schools could follow up independently for any future needs. Both schools were very grateful to receive the units and both schools had the units, along with their cases and signs, promptly installed.

Assurance*Link People to Needed Personal Health Service*Oral Health Care Coordination Completed for Couple

Staff met with a couple at a Housing and Urban Development Senior Housing apartment complex and helped them establish a new dentist close to them who accepts Medicaid. Staff spent time with the couple providing oral health education regarding their specific needs and left them with necessary oral hygiene aids.

Maternal, Child and Adolescent Health Staff Connects Families to Insurance

Maternal, Child, and Adolescent Health (MCAH) staff have been busy providing Presumptive Eligibility (PE) determinations for children and pregnant women. PE allows an individual/family immediate access to Iowa Medicaid while waiting for the Iowa Department of Human Services to determine whether the individual/family is eligible for ongoing Medicaid. When staff assists with PE, they also provide the individual/family resources regarding healthcare providers that accept Medicaid coverage. Staff identifies individuals in need of PE during direct MCAH services and at the department's immunization clinic, as well as receives referrals from schools and community partners. In some instances, individuals become aware of our services independently and self-refer for assistance.

*Assure a Competent Public and Personal Health Workforce*Ethics Training at St. Ambrose University School of Social Work

Staff attended the St. Ambrose University School of Social Work training, "All Things Ethics: NASW Code Changes, Challenges of Current Policy Context, and Being Relentlessly Ethical." The training objectives included:

- 1) Articulate and apply the changes to the 2018 National Association of Social Workers (NASW) Code of Ethics;
- 2) Develop strategies based on the 2018 NASW Code of Ethics to intervene in current policy context; and

- 3) Implement strategies to prevent burnout in an ever-changing and challenging environment.

Changes to the NASW Code of Ethics primarily focused on the impact of technology on practice and included the following concepts: informed consent provided to clients electronically still requires thorough explanation; practitioners must continue to consider security and privacy requirements when providing services like telehealth; online searches about clients should only be done with compelling professional reasons, like safety concerns; and understanding potential conflict of interest surrounding social media is essential (for both client and practitioner privacy). Attendees also completed a “Civic and Political Activities” self-assessment and discussed the social worker’s ethical call to advocacy, considering how providing advocacy may positively or negatively impact the working environment with colleagues, community partners and clients (especially in light of social media).

Environmental Health Tabletop Exercise

Staff attended the annual Region 6 Environmental Health Department meeting in Toddville, IA. A tabletop disaster drill was held. The scenario was that several counties in the region were dealing with severe flooding. Discussion was held regarding whom to call for additional assistance and if there are any memorandums of understanding already in place to support resource sharing.

Genesis Trauma Conference

Staff attended the Genesis A-Z Trauma Conference on November 2, 2018 and assisted with the presentation of a Stop the Bleed training to the more than two hundred hospital personnel from the local area in attendance. The training discussed bleeding control steps and the application of combat assistance tourniquets.

Child Passenger Safety Technician Class

Staff attended the Safe Kids sponsored Child Passenger Safety Technician class on November 7, 2018. The course trains individuals on the appropriate way to install, and to teach others how to install, child safety seats. This training class was seen as a good opportunity to increase the injury prevention services that can be provided by the Health Department. The department has had this expertise internally in the past. The course ended with a safety check event at Central Fire Station in Rock Island.

Childhood Lead Poisoning Prevention Program

Clinical and Environmental staff members attended the bi-annual Childhood Lead Poisoning Prevention Program (CLPPP) Regional Meeting. Representatives from IDPH presented information on the School Match Program and the updated performance model with a goal of ensuring that Iowa counties meet the top three priorities in Iowa for CLPPP. These priorities include: increasing the number of children tested; increasing the number of confirmed blood lead levels (BLL); and increasing the percentage of children with elevated BLL who receive coordinated care. Attendees were also educated about the data management system utilized within the lead program.

Positive Behavioral Interventions and Support Webinar

Staff viewed the webinar “Bringing PBIS to Early Childhood Programs: The Prevention of Challenging Behavior and the Promotion of Young Children’s Social Emotional Competence.” Positive Behavioral Interventions and Support (PBIS) is a framework of evidence based practices embedded in play and routine activities that promote social/emotional, behavioral and learning outcomes. Implementation of PBIS requires training and professional development for staff and external coaching.

Hepatitis A Webinar

Staff attended a webinar on hepatitis A outbreak prevention. The webinar was sponsored by CDC and discussed the increase in the number of community-wide hepatitis A outbreaks in multiple states. For these outbreaks, CDC recommends vaccination for persons who report drug use (injection and non-injection), persons at high risk for drug use (e.g., participating in drug substitution programs, receiving substance abuse counseling or treatment, recently or currently incarcerated), men who have sex with men, and persons experiencing homelessness. CDC also encourages vaccination in certain settings such as emergency departments and corrections facilities in outbreak-affected areas.

Inform, Educate, and Empower People About Health Issues

Education Provided for Eighth Grade Students

Davenport West High School had an event for eighth grade students and their parents/guardians. Staff provided information on adolescent wellness exams and the ninth grade dental requirement, as well as how to get connected to insurance coverage, medical, and dental homes.

Breastfeeding Class at Pregnancy Resources

Staff provided a breastfeeding class at Pregnancy Resources in November. Four mothers attended this class. These mothers were also linked to dental care providers. All of these mothers were also referred to Parent Pals, a home visiting program for pregnant and new mothers.

Immunization Education Provided to Teen Moms

Staff presented immunization education to the teen moms group at Mid-City High School. Topics covered included the importance of HPV/Gardasil/influenza vaccine. Immunization schedules and vaccines for all ages, birth through adult, were discussed.

Safer Foundation Students Receive HIV/STD Prevention Education

Staff presented HIV/STD prevention education to the Safer Foundation. Topics covered included signs and symptoms of STDs, updated facts about HIV transmission, testing, and prevention (PrEP). This month staff were able to begin HIV testing as part of the education, and four adolescents who are at risk were tested.

Community Event Provides Opportunity to Educate on Lead

Staff attended a community event sponsored by the Davenport Community School District's Family Involvement Liaisons (FIL). This event brought together parents and FIL to provide education related to district educational philosophies and teaching practices, as well as parenting strategies for school-aged kids. Information was provided to those present regarding sources of lead, recommended testing schedule, and nutritional/environmental interventions used to decrease absorption of lead. Approximately fifty people benefited from attending this event.

Education Provided at Palmer College of Chiropractic Vendor Day

Staff was invited to attend Palmer College of Chiropractic's November 2018 Vendor Day. Staff discussed available SCHD programs and services with approximately one hundred students (many new to the Scott County area), and encouraged them to reach out to SCHD for their own needs, as well as the needs of patients they see in clinic and in the community.

SCHD Annual Report Published

The department's Fiscal Year 2018 Annual Report was finalized in November. The report describes some of the highlights of the public health work and resource management accomplished by Scott County Health Department in the past year. The report was distributed to two thousand four hundred and twenty-four e-mail subscribers through GovDelivery, as well as featured on the website and social media.

Outreach to Local Colleges

Staff completed outreach to several local colleges, including: Scott Community College (Belmont, Urban, West Davenport, and Blong Technology Center campuses), St. Ambrose University, Palmer College of Chiropractic, Capri College, Upper Iowa University, Ross College, and Purdue University Global. Staff provided information about the SCHD MCAH, Tobacco, and STD Programs. Staff from several of the colleges expressed enthusiasm about partnering with SCHD to help support the health of students and their families. Potential opportunities were also identified for SCHD staff to provide health education to the local college students, both in the classroom and health fair settings.

Mobilize Community Partnerships

Modern Woodman Financial Retirees Connect with I-Smile™ Silver

Staff connected with Ann Held from Modern Woodman Financial. Ms. Held leads a group of Modern Woodman retirees in monthly meetings. As a group, they choose a community outreach project in which they can make an impact by donating tangible items. For the 2019 year, they have chosen to focus on older adults and reached out to I-Smile™ Silver. Staff will give a presentation about the I-Smile™ Silver Program to them in January, as well as collect their oral health donations to deliver to an independent senior living HUD apartment complex.

Davenport Community School District Poverty Taskforce

Staff attended the November 2018 Davenport Community School District (DCSD) Poverty Taskforce Committee meeting. This meeting brings community partner agencies together with school district representatives to discuss programming ideas and update on existing work to support families. DCSD provided an overview of some upcoming initiatives. In January 2019 DCSD is planning an event that will focus on connecting with students, and their caregivers, who are interested in entering a technical career industry. The district is planning to host a “Jump Start” workshop at Jefferson Elementary and Central High School for their staff that will focus on ensuring that students are not being referred to special education/behavioral remediation classes due to race or culture. DCSD is also setting district and building level goals and indicators to address the disproportionality currently seen of students of color in special education/behavioral remediation classes.

Community organizations also provided updates on efforts. The Iowa State Education Association received an operational grant for the community food pantry at JB Young. People Uniting Neighbors and Churches (PUNCH) will be taking over the day to day operation duties of the JB Young food pantry. In January, the Putnam Museum will be getting a new interactive and self-reflective exhibit called “Race: Are We That Different?” that will run until summer 2019. The City of Davenport anticipates receiving a Juvenile Justice Planning Report soon that will focus on two tiers of engagement. Tier One includes engaging with youth already in the juvenile justice system and Tier Two includes engaging preventive resources to support at-risk youth. The report will assist with future planning.

St. Paul Lutheran Church has hired a social worker that will provide free mental health therapy to families from the church and Madison Elementary School. The United Way of the Quad Cities is going to offer help to families with the Free Application for Federal Student Aid (FAFSA). Vera French advised that their Same Day Access clinic is going well and has offered the opportunity to connect several DCSD students to school based therapy services. One Eighty Zone, through a partnership with St. Paul Lutheran Church, is finishing the process of renovating their first affordable housing property for a Madison Elementary School family. The family should be able to have affordable house payments, and should own the property within ten to fifteen years if they follow the payment schedule. Work on a second house is anticipated to start soon. The City of Davenport stated that they are also working through the legal process to receive approval to partner with One Eighty for the renovation of city-owned properties for the affordable housing program.

Early Childhood Iowa Mental Health and Nutrition Professional Development Team

Staff attended the Early Childhood Iowa Health Mental Health and Nutrition Professional Development Leadership Team meeting. The meeting focused on reviewing the information, resources, and links provided on the Iowa Core Knowledge of Child Development page on the Iowa Association for the Education of Young Children’s website.

Scott County Immunization Coalition

Staff convened the second meeting of the Scott County Immunization Coalition meeting. The attendance numbers were down from the first meeting. The team shared the survey results from the last meeting. Most people preferred to meet midweek in the evenings. The top priorities for the coalition were also identified. The Coalition worked on a mission statement for the group. Several drafts have been developed based on the input from attendees. A survey will be sent out to the group in December to determine what mission statement they would prefer. The Coalition will meet again in January.

Collaboration with The Project to Develop Community Clinics

Staff has been meeting weekly with staff from The Project of the Quad Cities (TPQC) to assist them in planning and implementing an HIV Pre-Exposure Prophylaxis (PrEP) Clinic and a STD/HIV testing clinic in Moline. Their future plans are to offer hepatitis A/B vaccine and hepatitis C testing to clients. Dr. Katz has also attended several meetings since he has agreed to be their Medical Director.

Immunization Clinic Partnership at St. Ambrose University

In October, staff partnered with St. Ambrose School of Nursing to provide influenza immunizations to nursing and physician assistant students and staff. One hundred and seventy-four students and staff were vaccinated. After the clinics were completed, St. Ambrose sent out three evaluations: one to the nursing students who provided the vaccinations, one to the physician assistant students who screened the clients before they received the vaccinations, and one to the clients that received the vaccination.

Overall, everyone thought the clinics went well. A few takeaways were to: give the physician's assistant students more to do; research a way to add the cost of the vaccine to the students' fee, so they do not have to pay out of pocket and get reimbursed later; adjust the clinic times to better coincide with class schedules; have the students provide more education to clients before giving the vaccine; consider providing vaccine to the main campus; and include the junior and senior nursing students to assist. We anticipate continuing this partnership with St. Ambrose.
