Monitor Health Status

Communicable Disease Program

Fifteen communicable diseases were reported during March. They included seven cases of hepatitis C, three e. Coli infections, two cases of hepatitis B, and one case each of campylobacteriosis and hepatitis A.

Rabies Risk Assessments

Eighteen individuals required rabies risk assessments after exposures to thirteen dogs, four cats, and one bat. Rabies post exposure prophylaxis was recommended for ten individuals.

Childhood Lead Poisoning Prevention Program

In March, there were eleven children receiving individual case management. Of those, two had a blood level between 15-19 ug/dL. The remaining nine children had a blood lead level less than 15 ug/dL. Twelve children with an initial blood lead level between 10-14 ug/dL were receiving supportive services (visual inspections, education over the telephone, appointment reminders) for lead poisoning this month. Of those, four had a blood lead level between 10-14 ug/dL ug/dL and eight had a blood lead level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 5 ug/dL are obtained.

Seven children attending Scott County Health Department's (SCHD) Immunization Clinic accepted lead testing services during their visit. Five children were between the ages of one and two years. Two children were between the ages of three and six years. No new positives were identified. Scott County WIC locations completed ten lead tests in March; one new positive case was identified.

Diagnose/Investigate Health Problems and Hazards

Sexually Transmitted Disease Program

Eighty-six clients received sexually transmitted disease (STD) clinic services during March. Seven clients tested positive for chlamydia, six tested positive for gonorrhea, and one tested positive for syphilis at the Health Department's clinic. In total, eighty-eight cases of chlamydia, twenty-nine cases of gonorrhea, and four cases of syphilis were reported in Scott County during the month.

Evaluate Effectiveness, Accessibility and Quality

First Med Pharmacy Review

In February, two hundred and forty-eight inmates received one thousand and eighty-two prescriptions. The use of generic medication was at ninety-seven percent.

EPSDT Regional Informing Meeting

Maternal, Child, and Adolescent Health team members attended the Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) Regional Informing Meeting. The meeting brought all agencies that are providing Informing Services together to discuss each agency's processes, discuss program requirements, and to look for ways to make improvements.

Develop Policies and Plans

CHANGE Tool Discussed with City of Donahue

Staff met with the Mayor of Donahue to discuss developing or strengthening policies and/or environmental changes to promote physical activity, healthy eating, and chronic disease prevention. During the meeting, the Community Health Assessment aNd Group Evaluation (CHANGE) tool was completed. The CHANGE tool results and recommendations will be presented at an April Donahue City Council meeting.

NEMS-R Discussion with Go Fish Bar and Grill

Staff met with Krista Kay, Owner of Go Fish Bar and Grill, to review the Nutritional Environment Measures Survey – Restaurant (NEMS-R) results from last year. Ms. Kay expressed interest in implementing a few of the recommendations such as adding a fat free salad dressing, removing breadsticks as a side with salads, and identifying NEMS-R healthy options on the menu with an icon. Staff will be continuing to work with the owner on implementation.

North Scott Community School District Wellness Committee

Staff presented CHANGE Tool results and recommendations to the the North Scott Community School District (NSCSD) Wellness Committee. The Committee expressed interest in formalizing a health promotion budget, conducting a Nutrition Environment Measures – Vending (NEMS-V) assessment, supporting breastfeeding, and strengthening the tobacco free policy to prohibit the use of nicotine products. Staff will assist the committee with policy changes.

<u>Bettendorf Community School District Wellness Committee Completes CHANGE Tool</u> Staff met with Bettendorf Community School District (BCSD) Wellness Committee Members to complete the CHANGE Tool assessment. Currently, the BCSD provides staff access to the school gym, weight room, track, and school lunches; supports breastfeeding by providing a comfortable, private space for staff to nurse or pump; and offers biometric health screenings. The CHANGE Tool results and recommendations will be presented to the committee in April.

Founded Food Service Complaints

Coordination with IDPH Regarding Pool Heater

Staff has been in contact with the Iowa Department of Public Health's (IDPH) pool program engineer regarding a pool heater at an area high school swimming pool. Upon a routine inspection of the swimming pool, it was noted that a new heater had been installed. No reconstruction permit had been obtained, and the installation was not properly vented. School personnel have been working with a contractor to resolve the situation.

New Tattoo Establishment Fails Inspection

Staff inspected a new tattoo establishment in Davenport. The establishment did not pass the initial inspection due to inadequate handwashing facilities.

Research for new insights and innovative solutions

New Onsite Wastewater System Technology

Staff met with representatives from Premier Tech Aqua to learn more about their coco filters used in onsite wastewater treatment systems and associated maintenance contracts. This technology would be an option for homes when traditional or sand filter systems are not appropriate or will not work because of size limits. Staff does not anticipate high utilization of these systems in Scott County, but understanding existing technology is beneficial.

Salamander Technology for Resource Tracking

Staff met with Scott County Emergency Management Agency to discuss the transition of the Health Department and Facility and Support Services into the Salamander system. These two departments were chosen to begin the eventual county-wide move into the system. Salamander is a badge system that can be used to verify access to situations, track time and attendance at events, and generate reports. The initial push for these two departments to transition over was to prepare for potential flood response.

National Condom Month Survey Gathers Input

In observance of National Condom Month, staff conducted an online survey via Facebook. Respondents were asked what brands and styles of condoms they had used; their preferred brands and styles of condoms; what other HIV/STD prevention strategies they use; if they had accessed free condoms available from SCHD; and recommended community locations for the placement of condom dispensers. Results showed that the department has been largely providing respondents' favored brands and styles of condoms, and staff received a few new ideas to direct condom ordering in the future. Respondents' primary HIV/STD prevention strategy, beyond condom use, was monogamy/only one sex partner. About twenty-five percent of respondents had accessed free condoms from SCHD distribution sites while seventyfive percent had not. Hopefully the survey also raised awareness of this resource.

Discussion of Credentialing and Billing with PractiSynergy

Staff met with representatives from PractiSynergy to discuss the services their business could provide for SCHD. They shared how they can provide assistance regarding credentialing for

Medicaid, Medicare, and other private insurances. They also provided information about an electronic medical record that could be used in place of Practice Fusion, that would integrate with their billing system and includes a scheduling component. If interested, they could do the billing for the department; they would be paid a percentage of the amount received in payment. They can provide practice consulting services to support efforts regarding current and future billing.

Assurance

Link People to Needed Personal Health Service

HIV/Hepatitis C Service Outreach Testing Locations Continue

Regular HIV/hepatitis C (HCV) counseling, testing and referral services were provided at Scott County Juvenile Detention Center; Center for Alcohol and Drug Services; Humility of Mary Shelter; Alcohol and Drug Dependency Services in Burlington; Muscatine Center for Social Action; New Horizons Substance Use Treatment Facility in Muscatine; and by appointment at SCHD outside of regular clinic hours. In March, fifty-one individuals were tested for HIV and twenty-seven for HCV at outreach testing sites.

Preschool Health Information Provided

Staff offered health information packets containing health and immunization forms to childcare and preschool directors as they prepare for annual enrollment into their programs.

Presumptive Eligibility Medicaid Links Families with Care

Staff provided three families with Presumptive Eligibility Medicaid application services. One family was new to the United States and had no health insurance or health care providers for their family. Another family was in need of health insurance and connections to a medical home, including one that could authorize a release to return to school for their child who had been out due to illness.

<u>Child Referred to Area Education Agency for Additional Developmental Services</u> Staff completed the Ages and Stages Questionnaire along with the Ages and Stages Questionnaire: Social-Emotional for a young child. Our I-Smile[®] staff introduced the parent to *Care for Kids*. The child was referred to the Area Education Agency for further evaluation in regard to communication; gross and fine motor skills; and problem-solving. Follow up confirmed that the child qualified for early intervention services.

Assure a Competent Public and Personal Health Workforce

Syphilis Presentation Offered to Local Health Care Providers

Staff from SCHD and IDPH partnered to bring Dr. Bradley Stoner, MD, from the CDC STD/HIV Prevention Training Center in St. Louis to Scott County. Dr. Stoner provided a syphilis educational presentation to twenty-nine health care providers. The class was scheduled

because of the increase in syphilis cases being seen in the region, as well as throughout the state. Dr. Stoner covered signs and symptoms; stages of syphilis; ocular and neurological syphilis; and proper treatment as each stage.

Webinar on Unattended Food Establishments

Staff attended an Iowa Department of Inspections and Appeals (DIA) webinar to learn more about licensing and inspecting unattended food establishments. This type of operation provides packaged foods or whole fruit using an automated payment system and has controlled entry not accessible by the general public.

Pool and Spa Presentation to Pool Operators

Staff delivered a presentation to pool operators who were studying to obtain certification. Participants were instructed on compliance requirements to meet the Iowa Swimming Pool Rules.

Health Equity Spotlight Webinar

Staff participated in the monthly IDPH Health Equity Spotlight Webinar. March's topic was the impact of HIV on the health of women, and the stigma and barriers to care and prevention services they face. Guest speaker Tami Haught of Positive Iowans Taking Charge (PITCH) shared the story of her personal challenges after being diagnosed with HIV in the early 1990's, highlighting her struggle to access adequate medical care for herself and her husband. She also discussed the social stigma she faced from other parents and school administrators while raising her son.

Productive Conflict Training

Staff attended Scott County Human Resources' Productive Conflict training County led by Alan Feirer. The training offered attendees the opportunity to take the DiSC (Dominance, Influence, Steadiness, and Conscientiousness) assessment, which helped to identify the destructive and productive conflict behaviors of staff based on their personality. The presentation provided additional information about the different conflict styles, including how to manage responses to conflict and use communication strategies for productive conflict.

<u>Education on Activities Provided to Scott County Kids Early Childhood Iowa Board</u> Staff provided a brief summary of the Child Care Nurse Consultant role in Scott County to the Scott County Kids Early Childhood Iowa board. Current immunization rates for Scott County were shared and staff answered the Board's questions about Iowa immunization requirements for school and child care.

Presumptive Eligibility Medicaid Training for Schools Nurses

Staff provided Presumptive Eligibility training to three North Scott Community School District (NSCSD) nurses, two Bettendorf Community School District (BCSD) nurses and the BCSD high school social worker. The training provided guidance on how to complete the Presumptive Eligibility (PE) Medicaid application process with students and their families. Staff also helped

the nurses complete the next steps to apply for certification through Iowa Medicaid to be able to offer the PE application services. Staff will remain available to support the nurses as they begin to complete PE Medicaid applications. There are now a total of thirteen Scott County school nurses who can complete Presumptive Eligibility Medicaid applications.

Youth Mental Health First Aid Training

Staff attended the March 2019 Youth Mental Health First Aid training, offered by the Davenport Community School District (DCSD), and facilitated by Joe Wynsma, DCSD social worker, and Lynne Miller, mental health provider with Vera French. The training focused on mental health symptoms and warning signs and how to help support young people experiencing mental health issues, including those in crisis.

Bi-State Alternative Energy Conference

Staff attended the 2019 Bi-State Alternative Energy Conference. The sessions *Let the Sun Shine: Model Ordinances and Community Initiatives; From Brownfields to Brightfields: Repurposing Sites for Solar Farms; Good Neighbors: Prairie Patches and Pollinator Habitats at Energy Installations; and Money on the Table: Energy Efficiency Incentives for Municipal Facilities* were attended. In addition, staff completed the Environmental Protection Agency's *Particle Pollution & Your Patients' Health Course*. The course explained what size particles are the greatest health concern, how particle pollution exposure affects the cardiovascular and respiratory systems, and the value of checking the Air Quality Index daily to protect overall health.

Food Insecurity Conference

Staff attended the Western Illinois University-Quad Cities Food Insecurity Conference: Food Insecurity and Mental Health. Staff attended the sessions *College Students Need A Healthy Mind & Body to Make Good Decisions – Essential Components to Being Food Secure; Panel Discussion Highlighting the Connection Between Food Insecurity and Mental Health; and The Right to Food in the U.S.: The Role of SNAP.* Breakout sessions included additional information and resources from each presenter.

Child Abuse Annual Conference

Staff attended the Child Abuse Annual Conference. The keynote speaker, Frank Grijalva of the Midwest Trauma Services Network spoke on *The Trajectory of Neglect and Abuse*. Most cases of neglect occur before the age of one. The typical power-control relationship is ineffective with those who have experienced trauma. Providers must pay attention, identify the gap creating the unwanted behavior(s), and then fill in the gap with a consistent and predictable behavior to see the desired result.

Dr. Donna Beegle presented on *Breaking the Iron Cage of Poverty*. She spoke on poverty realities in America, types of poverty, the meaning of poverty, and the strategies to break poverty barriers. Though many strategies exist, Dr. Beegle focused on the importance of building relationships with persons living in poverty. Research has shown that moving out of poverty does not routinely come from working harder or being born smarter, but rather comes

from developing meaningful, supportive relationships with professionals that can assist them in navigating the middle class.

Finally, Dr. Chris Martin led an interactive session on *Implicit Racial Bias*. Explicit versus implicit bias was explored, and the audience was asked to identify examples of each. Then, the attendees participated in a group exercise that involved self-identification to listed categories based upon proposed questions. The exercise was used to help attendees better identify their own implicit biases. Attendees were encouraged to continue knowledge building related to the subject and to increase empathy for themselves and those served.

Inform, Educate, and Empower People About Health Issues

Stop The Bleed Training Offered to Community Coalition

Staff assisted MEDIC EMS in providing a Stop the Bleed Training to the Quad Cities Heartsafe Coalition. The training was offered in an effort to increase the overall health knowledge that this group has, and the information that they are able to spread to the community. Approximately twenty-fine individuals were trained during the event.

Childhood Lead Poisoning Prevention Education Provided to Parents

Staff spoke about childhood lead poisoning prevention with new parents and/or soon-to-be parents at the Baby Basics course offered by Genesis Health System. Education was provided about lead sources, as well as nutritional and environmental interventions used to decrease the chance of childhood lead poisoning. Education was also provided regarding the immunization and *Care for Kids* programs offered by SCHD.

Luther Crest Residents Educated on Oral Health

Staff discussed oral health as it relates to overall health with sixteen residents at Luther Crest senior apartment complex. Attendees were informed about the I-Smile[™] Silver program as a resource for them. One resident was assisted with finding a Medicaid dental provider that same day.

Planning for STD Awareness Month Underway

The STD team has been planning activities for STD Awareness Month in April. STD Awareness Month is a national campaign to raise awareness about the impact of STDs and the importance of prevention, testing, and treatment of STDs. The team will focus its efforts on syphilis awareness and encouraging young people to be tested for STDs. Activities include general marketing through existing methods, sending a memo to health care providers, and partnering with Eastern Iowa Community College to provide education to students.

Childcare Providers Educated on Childhood Lead Poisoning Prevention

Staff spoke about childhood lead poisoning prevention with childcare providers during an event facilitated by SCHD's child care nurse consultant. Education was provided about lead sources, as well as nutritional and environmental interventions used to decrease the chance of

childhood lead poisoning. Education was also provided regarding the regulations that affect caregivers as they relate to environmental lead.

Education Provided at Gathering of Women's Tea Party

Staff hosted a booth of Health Department program information at the Gathering of Women's Tea Party. This is an annual event where African American women are recognized for their contributions to the community in education, medicine, humanities, and religion. This year, women who were ninety years old and older were also recognized, along with young women in high school and college. This event is attended by two hundred and fifty to three hundred women from the surrounding communities each year.

Plans for National Infant Immunization Week Take Shape

Staff made plans to celebrate National Infant Immunization Week (NIIW) in April. Even though NIIW is one week out of the month, SCHD will celebrate all month by providing educational information to parents when they bring their infants in for vaccinations. Staff will give parents a bag with information regarding protecting their infant against pertussis, a CDC recommended immunization schedule, hand sanitizer, a baby bib, chip clip, and infant toothbrush. Staff will also have Facebook infographics and posters throughout the building. The committee is working with the maternal health staff to distribute baby bibs and immunization schedules to obstetrician offices.

Education Provided to Burlington High School Students

Staff provided STD/HIV prevention education sessions to Burlington High School students as part of the school's annual health fair. The event is a partnership with Burlington Public Schools, Des Moines County Public Health, Family Planning of Southeast Iowa, and IDPH. Students learned about the signs and symptoms, testing and treatment resources, and prevention strategies related to the most common STDs and HIV. After the education session, the students had the opportunity to be tested for chlamydia and gonorrhea.

Mobilize Community Partnerships

Davenport Community School District Poverty Taskforce

Staff attended the March 2019 Davenport Community School District (DCSD) Poverty Taskforce meeting. Local community agencies shared pertinent programming updates. Mike Miller of the River Bend Food Bank advised that due to the Trade Mitigation Program, they have been able to increase the amount of fresh food (dairy, vegetables, fruits) distributed to food banks. They have also increased the number of mobile food pantries that they are offering and have opened a new food pantry at the South Park Mall.

Kelly Larned, Program and Operations Manager for the Salvation Army, talked about the Quad Cities Coordinated Entry Program. Connecting people to shelter and housing services is now a streamlined process through the central hub located at the Salvation Army office. Sarah Ott, City of Davenport, reported that they are working to save abandoned properties through a court process and by developing strategic partnerships with Scott County. They are working with the City Assessor's Office and the Board of Supervisors to attempt to change the tax sale certificate process. The end goal would be to keep property ownership with local residents.

Discussion with City of Davenport Regarding Lead Resources

Staff met with Letty Goslowsky, City of Davenport Revitalization Supervisor, about funding available to home owners with an identified lead poisoned child in the home through the City's Owner Occupied Housing Rehab Loan Program. Live Lead Free QC plans to work with the City of Davenport to identify qualified applicants affected by lead and to assist with getting homes remediated.

Scott County Prescription Drug Advisory Council

Staff attended a meeting of the Scott County Prescription Drug Advisory Council. The group discussed a plan for the organization moving forward, including electing officers and outlining their duties, expanding of the mission of prevention to include all drugs of abuse and alcohol, and inviting participants to seek a letter of commitment from their agencies to support a grant application that would be used to fund drug abuse interventions in local high schools.

Community Planning Underway for Kids and Community Connections Summit

Staff attended a meeting with Tera Weets and Michele Cullen from Genesis VNA; Diane Martens, Scott County Kids Early Childhood Iowa; Jennifer Best, Iowa State Extension; Jennifer Praet, Lutheran Services of Iowa; and Shari Huecksteadt, Mississippi Bend Area Education Agency (MBAEA), to continue to plan for the Kids and Community Connections Summit scheduled for June 5, 2019, at MBAEA. The summit is targeted toward nurses, social workers, mental health professionals, Department of Human Services staff, school counselors, educators, and early childhood support providers. The goal is to have a targeted discussion on how to break down the silos that exist between providers and join forces to implement a family-centric continuum of care that has a positive impact on protective factors that support families and children.
