Assess and monitor population health status, factors that influence health, and community needs and assets

# Community Health Improvement Plan Progress

Staff partnered with Community Health Assessment (CHA) Steering Committee members (Rock Island County Health Department, Quad City Health Initiative, Genesis, UnityPoint Health — Trinity, and Community Health Care, Inc.) to hold a Community Health Improvement Plan (CHIP) Stakeholder Committee meeting. CHA partners reviewed the 2019-2022 CHIP and shared updates on progress made for strategies under the three priority areas: mental health, nutrition, physical activity, weight, and access to care. Due to the COVID-19 pandemic, implementation of many of the health improvement strategies were interrupted, so the CHA partners have committed to transitioning several strategies into the next health improvement plan. Stakeholders worked in small groups to brainstorm how to improve the strategies or add new ones to better address the social determinants of health and/or impact health equity disparities occurring in the Quad Cities community. Department staff plan to review the group's ideas and start drafting the next health improvement plan for 2022-2025. A second meeting will be held later this fall with the Stakeholder Committee to review and finalize the plan.

Investigate, diagnose, and address health problems and hazards affecting the population

## Communicable Disease Program

A total of 713 communicable diseases were reported during September. They included three cases of hepatitis C, three cases of hepatitis B, two e. Coli infections, two cases of salmonellosis, and one case each of hepatitis A, cryptosporidiosis, and shigellosis. In addition, there were 700 laboratory-confirmed cases of COVID-19 reported.

In partnership with the Iowa Department of Public Health (IDPH) and the Iowa Department of Inspections and Appeals (DIA), staff have been investigating complaints of students becoming ill at five different schools in one of the local districts. SCHD was notified on September 29 that 26 children were ill (vomiting, stomach cramping) after eating a school provided snack. Interviews of children and their parents/guardians were completed and testing of the product also occurred.

#### **Rabies Risk Assessments**

In September, 47 individuals required rabies risk assessments after exposures to 23 dogs, 13 cats, four bats, and one goat. Four animals exposed more than one person. Twenty-three victims were recommended for rabies prevention treatment for a high-risk exposure or a bite above the shoulders and 18 started the treatment.

## <u>Childhood Lead Poisoning Prevention Program</u>

In September, there were five children receiving individual case management. Of those, three had a blood level between 20-44 ug/dL and two had a level between 15-19 ug/dL. These cases receive case management until they meet closure criteria. Six children with an initial blood lead level between 10-14 ug/dL received supportive services for lead poisoning during the month. Five children have a blood lead level between 10-14 ug/dL and one has a level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 3.5 ug/dL are obtained. Eleven children attending the department's immunization clinic accepted lead testing services during their September visit. There were no new positives identified during this effort.

#### Sexual Health Program

Seventy-four individuals received sexually transmitted infection (STI) clinic services during September 2022. Twelve clients tested positive for chlamydia, eight clients tested positive for gonorrhea, and three clients tested positive for syphilis at the Health Department's clinic. In total, 91 cases of chlamydia, 38 cases of gonorrhea, and four cases of syphilis were reported in Scott County during September. An additional 27 syphilis cases were investigated and determined to be either out of jurisdiction, old cases, not identified as a syphilis case, or had a pending case status. These cases were closed or referred. One HIV case was reported, but later identified as previously positive.

# **Policy Development**

Communicate effectively to inform and educate people about health factors that influence it, and how to improve it

#### Influenza Vaccine Educational Campaign Planning

The Immunization Services Team started planning for the influenza vaccine educational campaign for the fall. Staff met with a representative from OnMedia, who has helped other department programs with different advertising campaigns. OnMedia will create a video advertisement to encourage people to get their influenza shots. This ad will be used on YouTube and streaming television platforms. OnMedia will also be creating a digital display ad that will pop up on mobile apps to reach individuals at specific locations in the county. These ads will link to the department's website where individuals can find information about influenza, everyday preventive actions, and a link to vaccines.gov to find a vaccine location.

# **Education Provided at Community Events**

Staff hosted a vendor booth at a Back to School Bash sponsored by the Davenport YMCA's satellite office in Fairmount Pines. Staff engaged the community regarding health and wellness information, including direct program referrals as appropriate. Staff also participated in the Fall Pride Festival. Health and wellness information and activities were shared. HIV tests were administered to interested persons and monkeypox vaccine was offered. Finally, staff hosted a vendor booth at Vera French's Employee Health Expo. Staff engaged the employees by offering sexual health information as well as explaining the services offered by the department.

## Oral Health Educational Material and Supplies Provided

Staff provided educational materials and oral hygiene supplies to school nurses at five Scott County schools and offered to provide oral health services. I-Smile™ at School funds were used for the supplies for education were given to Washington, Hayes, and Madison Elementary Schools in Davenport and Neil Armstrong and Mark Twain Elementary Schools in Bettendorf.

#### Food Rescue Workshop

The Food Rescue Partnership (FRP) hosted its fourth Food Rescue Workshop. Forty-two attendees learned how food waste and reduction trends have changed during the COVID pandemic, a local model for a personalized healthy food pantry, and how to compost at home. All attendees received a food rescue resource kit which included the FRP's Resource Guide on Food Rescue, and food scrap container to compost at home. At the event, the Quad Cities Food Rescue Warrior and Member of the Year were announced as well.

Strengthen, support, and mobilize communities, and partnerships to improve health

#### **Development of Tobacco Prevention Presentations**

Department staff is collaborating with prevention staff from the Center for Alcohol & Drug Services, Inc. (CADS) to develop two new tobacco prevention presentations. One will be for students, and the other one for "youth influencers", adults who work with young people. The team will be providing these presentations to freshman health students at Pleasant Valley High School and to Davenport Community School District (DCSD) nursing staff in October, as well as to other groups in the future.

#### Collaboration with St. Ambrose University on Influenza Vaccine Clinics

Staff attended the first of two St. Ambrose University (SAU) influenza clinics where 93 students/staff were vaccinated against influenza. Department staff monitored appropriate storage and handling conditions at every link in the cold chain for the vaccine. This is an ongoing partnership which provides the nursing and physician assistant students at SAU with real world experience regarding mass vaccination clinics.

# Scott County Kids Exploring Developmental Screening at Child Care Locations

Staff participated in a meeting led by Scott County Kids on Ages & Stages Developmental Screening (ASQ). Kristy Roosa, Iowa DHHS Maternal, Infant, and Early Childhood Visiting Program Professional Development Coordinator also participated. Ms. Roosa trains early childhood professionals to complete ASQ screenings and report results to families. Staff shared the department's process of completing ASQ for clients in the Child Health Program. Scott County Kids staff collected information on how to make ASQ screening process and supporting tools available for local child care providers.

#### **Open Network Supports**

Maternal Health staff met with staff at Open Network to discuss new funds available to help support families with obtaining formula. Families in Rock Island and Scott Counties are eligible

for a gift card to use at BP, Hy-Vee, and/or Wal-Mart to use toward formula or gas. The program is connected to the Supplemental Emergency Assistance Program (SEAP).

#### Davenport District Dental Society Fall Meeting

Staff attended the Davenport District Dental Society's fall meeting to learn about the legislative priorities the organization will be pursuing this year, inform local dentists of the status of oral health in the community, and give program updates for I-Smile™ and I-Smile™ Silver. The Iowa Dental Association plans to continue to address concerns with Medicaid dental reimbursement in the coming year.

# <u>Collaboration Regarding Services in Cedar, Clinton, and Jackson Counties</u>

Staff met with Sherri Hunt, Early Childhood Iowa (ECI) for Cedar County, to discuss availability of ECI funds to support early childhood oral screenings at child care centers in Cedar County. To date, ECI funds have been used to pay for dental screenings, education and fluoride varnish services for children as provided by I-Smile™. Discussions are underway to explore a subcontract to continue this work in Cedar County for fiscal year 2023.

Staff also met with Michele Cullen with Genesis Visiting Nurses Association and Clinton/Jackson County Public Health to review plans to subcontract Child Care Nurse Consultant (CCNC) services for Cedar, Clinton and Jackson Counties, and Child Health direct care (lead screening and developmental screening) services for Clinton and Jackson Counties.

Maternal Health staff attended the Cedar County WIC clinic to determine workflow and identify community resources in Cedar County. Direct services will be offered at the Cedar County Public Health Department WIC clinic starting in October 2022.

Create, champion, and implement policies, plans, and laws that impact health

# <u>Tobacco and Nicotine – Free Policy Technical Assistance Offered</u>

Staff provided tobacco and nicotine – free (TF/NF) policy technical assistance to PCT Ebeam and Integration, LLC; Ascentra Credit Union; and the City of LeClaire. All three organizations received draft policies, guidance about the public health benefits of having a TF/NF comprehensive policy, and cessation program (Quitline Iowa and My Life My Quit) information.

#### Conclusion of Physical Activity Access Project

Department and Bi-State Regional Commission staff wrapped up the Physical Activity Access project in the City of Buffalo. Project staff presented a final overview of the walk audit, senior needs assessment, and pop-up projects to Bi-State Regional Commission, Buffalo City Council, Bi-State Transportation Technical Committee, River Way Steering Committee, Bi-State Regional Trails Committee, and Quad Cities Metropolitan Planning Organization Transportation Policy Committee throughout August and September 2022. The pop-up demonstration projects received positive feedback from Buffalo residents and community partners. The City of Buffalo intends to maintain the crosswalk paint.

#### School Immunization Audits Underway

Staff completed preliminary record reviews for immunizations in the non-public schools to prepare them for the official immunization audit. Staff continues to work with staff and parents to follow up with required immunizations. Staff also continues to meet with childcare center staff for immunization record pre-audits. During these visits, if the center has complete immunization records, the immunization audit form is completed.

A team of staff began the immunization audit process in the public and non-public K-12 schools. Last year the state moved up the audit due date from December to October. The October deadline was requested again this year, which means audits must be started close to the beginning of the school year. Audits are well underway, and staff believe the October deadline will be met. Childcare audits are due in January and staff will begin working on those once the K-12 are completed.

# **HIV and Hepatis Community Planning Group**

Staff attended the HIV and Hepatitis Community Planning Group meeting in Des Moines. Participants were able to learn of and provide feedback on the direction of HIV/hepatitis C legislation and the Stop HIV lowa Plan. The development of the Stop HIV lowa Plan consisted of exploring nine focus areas, some of which were sexually transmitted infections, primary prevention of HIV, health equity, and social determinants of health. Each focus area conducted focus groups, individual surveys and key informant interviews to gain feedback from communities, health care providers, and organizations across the state. Four goals were created with objectives and strategies. The plan will be posted for public comment in October. It will then be revised based upon comments and the final plan will be submitted in December.

Utilize legal and regulatory actions designed to improve and protect the public's health

#### Complaint of Cockroach Complaint at Hotel

Staff conducted an investigation at Wood Spring Suites, Elmore Circle, Davenport twice at the end of September due to the presence of cockroaches in several rooms. Environmental health staff received multiple calls and emails from occupants regarding the pest infestation, which triggered the investigation. The facility shut down for a day to allow Orkin to complete thorough pest control work. Staff will continue to monitor this situation.

#### **DIA Changes Inspection Frequency for Facilities**

With the new Home Food Processing Establishment (HFPE) act and passage, DIA has changed the inspection frequencies of all food establishments. DIA's inspection frequency is as follows:

**Low Risk HFPE:** prior to inspection & upon a received complaint only

Medium Risk HFPE: every 84 months

High Risk HFPE: every 36 months but may be adjusted to every 24 or 12 months based on

inspection history

**Annual Temporary Food Establishments & Annual Farmers Market Food Establishments:** annually

**Risk Level 1 Food Establishments:** prior to inspection & upon a received complaint only **Risk Level 2 Food Establishments:** every 60 months but may be adjusted to every 48 months or 36 months based on inspection history

**Risk Level 3 Food Establishments:** every 36 months but may be adjusted to every 24 months or 18 months based on inspection history

**Risk Level 4 Food Establishments:** every 12 months but may be adjusted to every 6 months based on inspection history

**Risk Level 5 Food Establishments:** every 6 months but may be adjusted to every 4 months based on inspection history

Local boards of health (BOH) may adopt a different inspection frequency, as long as it is not less strict than the state's frequency. However, there are logistical challenges with the database that result if the frequencies are not the same. Staff is evaluating the information, talking with other contractors, and will be developing a recommendation for consideration by the BOH.

#### Assurance

Assure an effective system that enables access to the individual services and care needed to be healthy

#### Discussion of Care Plans at Preschools

Staff met with individuals at two preschools to provide education and support as they prepare to care for children with seizure disorders. These discussions between the department's child care nurse consultant and preschool/child care providers is critical for understanding the best way to support children with special health care needs.

#### Monkeypox Outreach Clinics Offered

The department hosted three monkeypox vaccine (Jynneos) outreach clinic events in September. Approximately 80 people received the vaccine, as well as education regarding how to reduce the risk of contracting the illness. In addition, same day access continues to be offered for individuals interested in receiving the vaccine. Demand for the vaccine across the state is down as the number of cases reported across the country continues to decline.

## **Education Provided to Health Care Providers**

Staff provided oral health and Hawki outreach education for pediatric and family practice providers at the Health Plex in Bettendorf and Bettendorf Pediatric & Family Practice Associates. Provider offices received information about how to facilitate referrals to I-Smile™ for children's dental care, available training for oral screenings and fluoride applications, and how to connect patients to the Child and Adolescent Health Program for presumptive eligibility determinations for Medicaid and Hawki coverage.

# First Med Pharmacy Review

In August, 219 inmates received 883 prescriptions. During the month, 98.3 percent of medical and 99.7 percent of mental health medications were generic.

# Presumptive Eligibility Services Continue

Staff completed presumptive eligibility (PE) Medicaid applications for pregnant people who needed prenatal care, including non-citizens. This PE process allowed them to access immediately while they wait for Iowa HHS's formal decision.

Build and support a diverse and skilled public health workforce

#### Monkeypox Outreach Communication Webinar

Staff attended the webinar *Communicating about the Monkeypox Outbreak: Lessons from the Social and Behavioral Sciences*. The webinar addressed common misconceptions about the monkeypox virus and educated healthcare and public health workers regarding how to discuss the virus and screen clients without stereotyping.

#### Breastfeeding and the Black Experience Webinar

Staff attended the *Breastfeeding and Black Experience* webinar hosted by Iowa HHS. This webinar expanded on the history of black experiences and breastfeeding. It helped staff to better understand the experiences and challenges of black people and have tools to help them be successful with breastfeeding.

#### Home Food Processing Establishment Training

All Food Program staff attended Home Food Processing Establishment Training regarding the implementation of House File 2431 which during the 2022 Legislative Session. This rule allows individuals to make food from home to sell, with a limited number of restrictions. The training covered DIA's implementation plan regarding enforcement, foods that can and cannot be sold, inspection frequencies, and inspection reports.

#### **COVID-19 Communication Briefing**

Staff attended a COVID-19 narrative briefing from the CDC and California Department of Public Health. The online session shared several online narratives that may undermine confidence in COVID-19 vaccines and tactics to counter them.

#### FDA Retail Food Protection Seminar

Food Program staff attended the annual Retail Food Protection Seminar. The seminar provides an opportunity for food program regulators at the federal, state, and local levels to discuss current and emerging issues related to retail food safety. The seminar had a focus on norovirus, including assessing employee health, investigating norovirus related foodborne illnesses, and implementing successful employee health intervention strategies.

#### Maternal Health Diversity, Equity, and Inclusion Training

Staff attended a Maternal Health Diversity, Equity, and Inclusion Training hosted by the Iowa HHS Doula Program. This six-hour training, presented by LaDrina Wilson, addressed implicit bias, microaggression, race/structural racism, and cultural humility. The lecture and dialogue allowed staff to explore and firm up their stance on issues of healthcare inequities.

Improve and innovate public health functions through ongoing evaluation, research, and continuous quality improvement

#### Quad Cities Committee Prepares to Test Response

Staff worked with the Quad Cities Centers for Medicare and Medicaid (CMS) Certified Agency Committee to help prepare organizations for a tabletop and functional exercise involving a tornado that knocks out power during high heat. The committee developed exercise objectives and goals for each type of entity (hospitals, long-term care facilities, and home-health organizations).

#### Discussion on Retail Food Standards and Self-Assessment Process

One of the requirements of the department's contract with DIA is that the department shall maintain, in good standing, enrollment in the FDA's Voluntary National Retail Food Regulatory Programs Standards including completing and submitting a self-assessment of all 9 Program Standards to the FDA at least once every 60 months. The department's next self-assessment is due to be completed in November 2022. In light of many new individuals working in the Food Program, staff took the opportunity to meet with Mike Nordos, FDA Retail Food Specialist, to discuss the 9 Food Standards and the self-assessment process.

Build and maintain a strong organization infrastructure for public health

#### Final Training for New Inspection Database

Environmental staff attended training regarding the new environmental health database developed by Scott County Information Technology. This new database will be used to document all swimming pool, spa, tanning, and tattoo facility inspections. The team has been working the development for the last year.

#### Subcontracting Expectations Review

Program and fiscal staff attended a virtual technical support meeting the Iowa HHS Family Health Bureau to learn expectations and best practices for subcontracting services as the Maternal Health, and Child and Adolescent Health programs switch transition to collaborative service areas in October. Participants had the opportunity to ask questions and discuss challenges with state staff.

## **Department Infrastructure Teams**

#### **Quality Improvement Council**

The QI Council distributed and tallied the results of the QI Culture of Quality survey that was distributed to all staff and the leadership team. The results will allow the QI Council members to determine what the level of culture of quality the department is at currently, and will be used to develop a workplan to make improvements.

#### Health Equity Committee

The Health Equity Committee provided an interactive Health Equity 101 update during the September 2022 All Staff meeting. The training focused on addressing topics related to social determinants of health and shared the importance of understanding equity versus equality. Committee members continue to participate in a group viewing of the documentary Unnatural Causes, which addresses the racial and socioeconomic dimensions of health inequities in the United States. The committee continues to work on a draft Health Equity Plan and next steps for the annual workplan.

#### Legislative Committee

During September, Committee members reached out to other local public health departments to inquire regarding their legislative activities and whether they have a formal or informal process. Resources from national public health associations were also reviewed. In addition, members joined both the Iowa Public Health Association (IPHA) and Iowa Environmental Health Association Advocacy Committees. The public health section of the Iowa State Association of Counties is also reengaging its efforts. Committee members will rely on these organizations to identify statewide legislative priorities. Finally, members participated in candidate forums sponsored by IPHA. These forums provided an introduction to public health for candidates running for state office. At least one Scott County candidate was in attendance. Our department was asked to share about public health in Scott County at one forum.

#### Workforce Development Committee

The Workforce Development Committee continues to work with the University of Iowa College of Public Health to plan for the staff workforce development assessment to be sent out to all staff in January 2023. The Committee continues to review pieces of the plan with hopes that once the survey results are compiled, they can be plugged into the report and the plan will be ready for approval.

#### Workplace Culture Committee

The Workplace Culture Committee has selected the National Association of County and City Health Official's Joy in Work Toolkit to guide its work. Many of the principles in the plan were found in other plans that were identified. With the framework selected, the team will begin developing an implementation plan. The Committee also officially adopted the name Workplace Culture Committee, and has begun formalizing committee operations.

#### Health Promotion Team

The Health Promotion Team has been busy finalizing COVID-19 promotional messages with OnMedia. The team worked on creating a FY23 work plan which includes focusing on a Health Promotion Strategy for National Infant Immunization Week, updating inventory logs within the department, surveying staff for department promotional needs, working on the Health Promotion Plan, developing a health promotional calendar, social media posts, etc.
