Assessment

Assess and monitor population health status, factors that influence health, and community needs and assets

Community Health Assessment Steering Committee Explores Offerings of Telligen

Staff attended the Community Health Assessment (CHA) Steering Committee meeting with representatives from Telligen QI Connect. Telligen staff are able to provide technical assistance at no cost to local partners in a variety of initiatives, including immunizations and chronic disease management. The Steering Committee expressed interest in reviewing the data Telligen has available from claims and public sources that could be useful in combination with the data from the CHA.

<u>Community Health Improvement Plan Work Continues</u>

Staff from the Rock Island and Scott County Health Departments continue to collaborate on efforts to complete a draft of the 2023-2026 Community Health Improvement Plan (CHIP) for both counties. As part of the work, staff have been meeting with several community partners to discuss relevant programs and initiatives already occurring in the community that could be written into the CHIP. Staff met with Scott County Kids staff to discuss the mental health priority area of the CHIP. The CHA-CHIP Stakeholder Committee and other community partners identified youth mental health as an area to address within this topic. Scott County Kids is working to address youth mental health needs in the community through a variety of initiatives. Staff also met with Tom Bowman, Community Health, Care Inc. (CHC) CEO, to discuss the mental health and access to care priority areas of the CHIP. CHC is expanding in both areas in order to address community needs.

Investigate, diagnose, and address health problems and hazards affecting the population

Communicable Disease Program

A total of 427 communicable diseases were reported during November. They included 10 cases of hepatitis C, two cases of hepatitis B, and one case each of campylobacteriosis, hepatitis E, shigellosis, and ehrlichiosis. In addition, there were 411 laboratory-confirmed cases of COVID-19 reported.

Rabies Risk Assessments

In November, 27 individuals required rabies risk assessments after exposures to 17 dogs, nine

cats, and one bat. Eight victims were recommended for rabies prevention treatment for a highrisk exposure or a bite above the shoulders and three started the treatment.

<u>Childhood Lead Poisoning Prevention Program</u>

In November, there were six children receiving individual case management. Of those, one had a blood level between 20-44 ug/dL, three had a blood lead level between 15-19 ug/dL, and two had a blood lead level less than 15 ug/dL. These cases receive case management until they meet closure criteria. Ten children with an initial blood lead level between 10-14 ug/dL received supportive services for lead poisoning during the month. Seven children have a blood lead level between 10-14 ug/dL and three have levels less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 3.5 ug/dL are obtained. Six children attending the department's immunization clinic accepted lead testing services during their November visit. There were no new positives identified during this effort.

Sexual Health Program

Seventy-five individuals received sexually transmitted infection (STI) clinic services during November 2022. Eleven clients tested positive for chlamydia and twelve clients tested positive for gonorrhea at the Health Department's clinic. In total, 81 cases of chlamydia, 37 cases of gonorrhea, and two cases of syphilis were reported in Scott County during November. An additional 20 syphilis cases were investigated and determined to be either out of jurisdiction, not identified as a syphilis case, or had a pending case status. These cases were closed or referred. One HIV case was investigated; it turned out to be a false-positive result.

Water Main Breaks Impacts Licensed Facilities

Two water mains in the City of Davenport ruptured on November 11th and were promptly repaired by Iowa American Water. A precautionary boil water advisory was issued for most of the west and southwest sides of Davenport and the entire community of Blue Grass. The advisory was scheduled to be lifted on November 13th, but was extended by Iowa American Water and the Iowa Department of Natural Resources (IDNR). The Health Department received several calls on November 14th and 15th from licensed establishments asking for advice and information. Approximately 70 licensed facilities were affected and all were emailed a boil order/boil advisory guidance document. The boil water advisory was lifted on November 16th. There were a variety of opportunities for improvement identified following this situation. Staff are working with Iowa American Water to assure that they have information on how to contact the department directly during work and after work hours.

Policy Development

Communicate effectively to inform and educate people about health factors that influence it, and how to improve it

Tobacco and Nicotine Presentation at Edgewater on Third

Staff presented to 20 residents and two staff from Edgewater on Third, a Department of Housing and Urban Development (HUD) senior housing location, about tobacco cessation. The

residents actively participated in a discussion about the following: the negative health effects of smoking and tobacco use; nicotine addiction; withdrawal symptoms and coping strategies; different types of cessation medications and cessation medication best practices; quitting tips; and the importance of accessing coaching and support, including through Quitline Iowa. Residents were advised about the availability of free cessation support services offered by Quitline Iowa, and given printed Quitline Iowa information and promotional giveaways.

Puberty Education at Trinity Lutheran

Staff provided puberty education to 24 fourth and fifth grade female students at Trinity Lutheran School in November, while a male staff member presented the education to the 30 boys. All students were provided with informational booklets relevant to hygiene and body changes that accompany the "growing up" process, along with a toothbrush and toothpaste.

Strengthen, support, and mobilize communities, and partnerships to improve health

Low Birthweight Workgroup

Staff attended the Low Birthweight Workgroup hosted by the Quad Cities Health Initiative. The group adjusted and revised the presentation designed for community groups. The feedback received from stakeholders so far has focused on the need for evidence-based interventions and best practices that may address low birth weight in Scott and Rock Island counties. Strategies suggested have included early prenatal care and expanding use of the Centering Pregnancy model, increasing participation in existing programs (like WIC, Maternal Health, and Home Visitation), screening/identifying pregnant people at risk of complications, and improving health education. The group continues to seek out local stories of those affected by low birthweight, to help share the impact it has on families.

As a follow-up to the discussion of the workgroup, staff attended the webinar, *Improving Health & Building Community Through Centering Groups*, to learn about the Centering Pregnancy model of delivering prenatal care. The model consists of establishing a group of eight to twelve pregnant patients and their partners (if desired) that attend an educational/support group at the same time as their prenatal visit with their provider. The model requires a provider, support staff, a trained group facilitator to lead the patients through a discussion of set topics. There are refreshments served and patients can connect with peers at the similar stages of pregnancy. Prenatal visits for each patient are scheduled before or after the group. The model has been validated and shown to improve outcomes for birthing parents and newborns, reducing low birthweight by 45%. There are initial training and curriculum costs to begin implementing the Centering Pregnancy model, but after that costs are minimal. In Scott County, there is currently one obstetric practice that hosts a Centering Pregnancy group for prenatal care.

TFQC Full Coalition Meets

Department staff facilitated the Tobacco-Free QC (TFQC) full coalition meeting. The group completed the Iowa Department of Health and Human Services (HHS) Division of Tobacco Use, Prevention, and Control Partnership Assessment Tool with coalition members. The tool collects

data on which organizations are members of the coalition, or are assisting with prevention and control work in the community. It also identifies which community sectors (i.e. education, health care, media, etc.) are represented through these organizations and how engaged they are in the coalition's work. This information will be used by the coalition to tailor community outreach and recruitment efforts.

Clinical Review/Provider Panel

Staff attended the Scott County Kids Clinical Review/Provider Panel. The group had a guest speaker from Vera French Mental Health Center's Health Assessment and Support Program. The program connects people that experience challenges accessing mental health care to services. They aim to reduce the impact of substance abuse and mental illness by providing support to those who are uninsured/underinsured.

Clinton/Jackson Early Childhood Iowa

Staff attended the Clinton/Jackson Early Childhood Iowa (ECI) November board meeting and annual legislative open house. To date, ECI has been supporting I-Smile™ services in early childhood education programs in Clinton/Jackson counties through subcontracts with I-Smile™ grantees. These funds cover the cost of education, oral health screening, and fluoride varnish services for children without Medicaid in those locations. Staff will continue to report to the ECI board regularly regarding the services being provided in Clinton and Jackson Counties.

Create, champion, and implement policies, plans, and laws that impact health

School Immunization Audits

Immunization audits for schools were completed and reported to IDPH. The total Scott County student enrollment was 29,026 for the 2022-2023 school year. Of the 29,026 students enrolled, 27,311 (94.09%) had certificates of immunizations, 328 (1.13%) had provisional certificates, 1,177 (4.05%) children had religious exemptions, 56 (0.19%) children had medical exemptions, and 154 (0.53%) had an unacceptable or no certificate (Attachment 2). This was the second year where we had seen a slight increase of nonacceptable cards.

Child Care Health and Safety Checklist Assessment

Staff conducted three Health and Safety Checklist assessments, one at a childcare home and two at childcare centers. Follow-up with all three programs is ongoing. The checklist is a compilation of best practice standards, that if followed, are most likely to prevent adverse outcomes for children/staff in early care and education settings. This assessment is a required component of lowa's quality rating improvement system, lowa Quality for Kids (IQ4K), for providers applying for levels three to five.

<u>Discussion Regarding Dental Assisting Program and Oral Health Education/Screening</u>
Staff met with Dawn Boettcher, MSN, RN, Dean of Health Programs, Eastern Iowa Community
Colleges via phone call. They discussed a collaboration with the Dental Assisting program to
provide oral health screenings for students and staff at the Belmont and Urban Campus

locations as well as the provision of oral health education for certified nursing assistant (CNA) and nursing students.

Utilize legal and regulatory actions designed to improve and protect the public's health

Swimming Pool/Spa Inspection Program

Staff met with John Kelly, HHS Engineer, as he conducted the pre-opening inspection of the pool facilities at the new North Scott YMCA facility. Accompanying Mr. Kelly on his detailed inspection gave staff an opportunity to learn about the intricacies of this complex system. Particularly interesting was his inspection of the exhaust system for the pool heaters. He observed a down draft and detected the presence of carbon monoxide. The building contractor has been notified of the situation and has assured that adjustments will be made to eliminate this hazard.

Staff participated in a conference call with HHS and the manager of the Off Shore Inn and Resort in Bellevue regarding the two near drownings that occurred this summer. After review of the circumstances surrounding both incidents, HHS concluded the incidents could not be attributed to any deficiencies in the operation of the facility. HHS discussed lessons learned and provided suggestions to enhance monitoring of patrons.

Tattoo Inspections Begin in Muscatine County

Staff has started the tattoo inspections in Muscatine County; five have been done to date. According to the HHS public portal, there are 10 currently licensed tattoo facilities. Securing contact information has been a challenging process. The only information available on the portal is the establishment's name. Staff have been utilizing social media and HHS staff to try to connect with the establishments.

Home Food Processing Inspections

Staff conducted the first two Scott County home food processing establishment (HFPE) inspections for this new type of licensed establishment. The HFPE license allows individuals who are licensed to make, package, and process foods in the home. The HFPE license was approved by the 2022 Iowa Legislature.

Assurance

Assure an effective system that enables access to the individual services and care needed to be healthy

Care for Yourself-WISEWOMN Annual Meeting

Staff attended the annual Care For Yourself (CFY)-WISEWOMAN meeting which discussed the fiscal year 2023 grant requirements, and discussed the process for helping clients get access to the program. The CFY-WISEWOMAN program is program designed to support healthy behaviors that encourage cardiovascular health. The target audience of the program is individuals that are enrolled in the CFY Breast and Cervical Cancer Early Detection program.

Health Screenings Underway at Non-Public Schools

Staff conducted health screenings at three of the non-public schools during November; 31 kindergarten students received dental screenings and 316 students received vision screenings. Following screening, staff works to connect the students with additional care. Three students were referred for a dental evaluation and 23 students were referred for vision evaluation. One kindergarten student had serious dental concerns and was referred to the department's I-Smile™ program; follow-up for this child is ongoing.

Children's Dental Services Resume

Staff has started providing dental screenings, applying fluoride, and offering oral hygiene instruction and education during the department's Immunization Clinic on Wednesdays. Staff also provided dental screenings, fluoride applications and education at the Cedar County WIC clinic. Visits are planned for WIC clinics in Jackson and Clinton counties in December. Staff is working with Head Start agencies to arrange education and dental screenings for locations in Cedar, Clinton, Jackson, and Scott Counties.

Presumptive Eligibility Services

Staff have completed Presumptive Eligibility (PE) Medicaid application services for parents/children. Individuals approved can access the full scope of medical, mental health and dental services Medicaid offers, while HHS reviews their applications for ongoing coverage. PE services can be provided at the department, in a community setting where staff are located, or virtually.

<u>Iowa Mission of Mercy Free Dental Clinic</u>

Staff participated in the Iowa Mission of Mercy (IMOM) free dental clinic in Des Moines. IMOM is a large scale, two-day community dental clinic where dental professionals and general volunteers donate their time to provide free oral health care to individuals who face barriers to receiving dental care. A full-service field dental clinic with 100 dental operatories is set up and patients are treated on a first-come/first-served basis. The 2022 IMOM event served 1,009 patients who received 6,732 procedures totaling \$1,013,537 worth of free dental care. Our staff

worked in the exit interview area, helping to direct patients to resources in their home communities as well as providing post-operative and oral health education. IMOM 2023 will be in Waterloo, lowa, the first time it has been in that community.

Hawki Outreach Kicks off in Collaborative Service Area

Staff provided Hawki outreach to Cedar County at two of its medical facilities, several preschools, and a local church in the Tipton area. In Scott County, staff provides weekly Hawki outreach to area schools, dental, medical and faith-based organizations and is currently working to target special populations without access to employer sponsored health insurance.

Build and support a diverse and skilled public health workforce

Basic and Advanced Epidemiology

Staff completed the Basic Epidemiology and Advanced Epidemiology courses. Basic Epidemiology is an online course that describes the basic terms and concepts of epidemiology practice, discusses the infectious disease process and methods to break the infection train, and to apply the information in a case study of a food-borne outbreak. Advanced Epidemiology builds upon the concepts in Basic Epidemiology and goes into more detail regarding the role of local health departments in disease response. It also provides more detail regarding the tools available to support the response: exclusions from work/school, isolation, quarantine, etc. These courses are required for staff completing routine disease investigation work and are recommended for those staff involved in emergency response.

Qualtrics Lunch and Learn Hosted by Johnson County Public Health

Staff attended a lunch and learn hosted by Qualtrics and Johnson County Public Health. The presentations demonstrated different utilizations of Qualtrics to advance public health initiatives, such as gathering data for community health assessments, completing case investigation and contact tracing, organizing vaccination clinics, and conducting employee feedback surveys. The department has a Qualtrics account and is exploring new ways to utilize it to support our work.

Salamander Inventory and Rapid Tag Training

Staff attended Salamander Inventory and Rapid Tag training at the Scott County Emergency Communications Center. The inventory training involved learning how to input, transfer, and search for inventory. The Rapid Tag training involved learning how to keep track of personnel and volunteers during a disaster. Salamander was used to track personal protective equipment and personnel working vaccination clinics during the COVID-19 response.

Conclusion of Food Allergy Webinar Series

Staff participated in the final webinar of a five-part series on food allergies from Food Allergy Research & Education (FARE). The webinar defined "high risk" infants and described the importance of early introduction of potentially allergenic foods and infant diet diversity. This guidance is a change from prior recommendation to avoid feeding allergenic foods.

Improve and innovate public health functions through ongoing evaluation, research, and continuous quality improvement

Inter-Rater Reliability Visit for Childcare

Staff successfully completed an inter-rater reliability visit at a child care center using the Health and Safety Checklist with Heidi Hotvedt, Child Care Nurse Consultant/Healthy Child Care Iowa Coordinator. This checklist is used in Iowa's childcare quality rating improvement system, IQ4K.

Iowa Medicaid Dental Stakeholder Referral Workgroup

The department's I-Smile™ Silver coordinator has been invited to take part in the Iowa Medicaid Dental Stakeholder Referral Workgroup. The organizations represented on the workgroup are: Iowa Primary Care Association, Iowa Dental Hygiene Association, Iowa Dental Association, Dental Connections (FQHC), St. Luke's Dental Health Center, I-Smile™, Broadlawns (FQHC), Oral Health Iowa, HHS Medicaid, HHS Public Health, University of Iowa College of Dentistry, Iowa Hospital Association, MCNA Dental, Delta Dental, Cavity Free Iowa, Provider Cost Audit (Iowa Medicaid), Medical Services (Iowa Medicaid), Member Advocates (Iowa Medicaid), Amerigroup, Iowa Total Care and Molina (medical managed care organization for Iowa Medicaid). The purpose of the workgroup is to look at maximizing resources and recognizing opportunities as they arise, increasing collaboration, sharing information, building partnerships, and developing a blueprint for action.

Community Preparedness Exercises

Staff attended the Quad Cities Medicare and Medicaid Certified Agency Full Scale Tornado Exercise. The role of department staff was to serve as a resource for any public health related calls by the entities participating in the exercise.

Staff participated in the Area 5 Healthcare Coalition pediatric surge tabletop exercise. The exercise was relevant to area hospitals as there has been a recent uptick of respiratory illnesses, including RSV. The exercise was designed to test plans for the region should pediatric hospital bed availability be limited in the region including how the situation and needs would be communicated throughout the partners.

Center for Acute Disease Epidemiology Site Visit

The Annual HHS Center for Acute Disease Epidemiology (CADE) site visit was held on November 30, 2022 with Diana Von Stein, who is the Regional Field Epidemiologist assigned to the department's region. She was very complimentary of the staff and the systems in place for monitoring and investigating communicable diseases. She also provided updates regarding CADE operations and discussed current infectious diseases being monitored (mpox, Ebola, etc).

HHS HIV and Hepatitis Prevention Program and Community-Based Screening Services Site Visit
The HHS HIV and Hepatitis Prevention Program and Community-Based Screening Services
(CBSS) team completed the Integrated Testing Services (ITS) and CBSS site visit this month. At
the site visit, Scott County staff gave a presentation highlighting successful endeavors, key
partnerships, and specific success and challenges related to the goals and objectives outlined in

the ITS contract. After the presentation, the HHS team reviewed the rapid testing quality assurance manual, HIV testing log, staff trainings during 2022, and verified the department's Clinical Laboratory Improvement Act (CLIA) certification.

The site visit also included reviewing the department's Sexual Health Program clinic facility assessment form, clinic level CBSS data, and quality assurance components of the CBSS program. The CBSS staff conducted a chart audit and verification that 340B medications were appropriately administered to clients. The site visit ended with the HHS team providing positive feedback regarding the work being done in Scott County.

Training on Nomad Handheld X-Ray Equipment

Staff received training on the handheld x-ray equipment, the Nomad. Scott County Information Technology and a representative from the manufacturer worked with staff to assure that software was working on laptops, and a sample image could be displayed and transferred electronically. The use of mobile radiology creates options for initiating teledentistry, and making efficient, appropriate referrals.

Build and maintain a strong organization infrastructure for public health

Department Infrastructure Teams

Quality Improvement Council

The Quality Improvement (QI) Council prepared content for the December All Staff meeting where they plan to introduce staff to the Spark Form, which can be utilized to generate ideas for quality improvement projects. They also plan to highlight past QI projects in an effort to get staff to start thinking of potential ideas. The QI Council also reviewed the Culture of Quality Assessment results and selected the following priority areas and foundational elements to work on in FY23:

- 1. Priority: Teamwork and Collaboration
 - a. Foundational Element: QI Team Performance
- 2. Priority: Customer Focus
 - a. Foundational Element: Meeting and Exceeding Customer Expectations
- 3. Priority: Continuous Quality Improvement
 - a. Foundational Element: Planning for QI Projects

Health Equity Committee

The Health Equity Committee continues to review and implement its annual workplan. Currently, the committee is surveying staff to identify "Health Equity in Action" projects that can be undertaken to supplement the ongoing training and assessment work the committee leads. Staff are being asked to identify ways in which the department can consider health inequities in physical space, program development, outreach activities, and more. Results of this survey will be reviewed by the committee and potential projects will be recommended for implementation.

Legislative Committee

The Legislative Committee sponsored the all staff training, An Overview of Iowa's Legislative Process and Legislative Website, presented by Deborah Thompson. The training reviewed the process of how bills are drafted and become a law, the structure of the Iowa General Assembly, and provided an overview of the legislative website. The training will help the department to better track legislation during the session.

In addition, an introductory letter was sent to all recently elected or re-elected State Legislators and Board of Supervisors members. A copy of the department's brochure was included, as well as an offer to meet to share more information and to serve as a resource for the elected officials on public health topics. Plans are being developed to share more information about the department on a more regular basis with elected officials.

Workforce Development Committee

The Workforce Development Committee is working with the University of Iowa College of Public Health to finalize the Workforce Development Assessment that will be sent to staff in early 2023. The Council on Linkages released updated competencies in October 2021, so work is underway to assure that the questions being asked align with the updated competencies.

Workplace Culture Committee

The Workplace Culture Committee continues to discuss how to implement the Joy in Work Toolkit within the department as well as develop a guiding plan for workplace culture efforts within the department.

Health Promotion Team

The Health Promotion Team provided assistance to the Workforce Development Committee by reviewing a communication question on the Workforce Development Assessment. The team continues to promote COVID-19 messaging throughout the community. Scripts for ads developed by OnMedia were reviewed and approved, as well as additional radio ad scripts for WGVV 92.5 FM. The team also extended an agreement to continue to provide COVID-19 messaging at the local DOT/DMV office.
