Assessment

Assess and monitor population health status, factors that influence health, and community needs and assets

Opioid Settlement Funds Planning

Staff and I met with Lori Elam, Scott County Community Services, to continue discussions regarding the opioid settlement funds that will be coming to Scott County. There are multiple settlements that will distribute varying amounts over several years. Some manufacturers and distributors have settled, and retail pharmacies are anticipated to settle soon. The group discussed using the Mobilizing for Action through Planning and Partnerships (MAPP) framework to assess community needs to determine the most appropriate use of funds.

Investigate, diagnose, and address health problems and hazards affecting the population

Communicable Disease Program

A total of 532 communicable diseases were reported during March. They included three cases of hepatitis C, one case of hepatitis A, and one case of hepatitis B. In addition, there were 527 laboratory-confirmed cases of COVID-19 reported. A total of 56,591 positive COVID-19 tests were reported between March 2020 and March 2023 in Scott County. As of April 1, 2023, COVID-19 has moved to a surveillance model and is being incorporated with the weekly Iowa Influenza Surveillance Report which can be found at <https://hhs.iowa.gov/influenza/reports>.

Sewage Backup Investigation

Staff investigated a sewage backup complaint at an apartment complex on Emerald Drive in Davenport. Sewage backed up into the basement level apartments. All apartments had to have the carpet removed and all floors had to have major cleaning conducted. The property manager was responsive to staff's requirements.

Rabies Risk Assessments

In March, 21 individuals required rabies risk assessments after exposures to 14 dogs, four cats, and two bats; one dog exposed two individuals. Nine victims were recommended for rabies prevention treatment for a high-risk exposure or a bite above the shoulders and nine started the treatment.

Childhood Lead Poisoning Prevention Program

In March, there were eight children receiving individual case management. Of those, two had a blood level between 20-44 ug/dL, one had a blood lead level between 15-19 ug/dL, and five had a blood lead level less than 15 ug/dL. These cases receive case management until they meet closure criteria. Four children with an initial blood lead level between 10-14 ug/dL received supportive services for lead poisoning during the month. One child had a blood lead level between 10-14 ug/dL and three had levels less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 3.5 ug/dL are

obtained. Ten children attending the department's immunization clinic received lead testing services during their March visit. There were no new positives identified during these efforts.

Staff conducted a lead investigation at a newly identified property in Davenport that was associated with a child who has an elevated blood lead level. Both internal and external lead hazards were identified at the property. Staff is working with the family and the property management company while lead remediation plans are being made.

Sexual Health Program

Sixty-seven individuals received sexually transmitted infection (STI) clinic services during March. Eight clients tested positive for chlamydia and five clients tested positive for gonorrhea at the Health Department's clinic. In total, 87 cases of chlamydia, 30 cases of gonorrhea, one case of syphilis, and two HIV cases were reported in Scott County during the month. An additional 22 syphilis cases and HIV cases were investigated and determined to be either out of jurisdiction, not identified as a syphilis case, or had a pending case status. These cases were closed or referred.

Policy Development

Communicate effectively to inform and educate people about health factors that influence it, and how to improve it

Community Education on Tobacco and Vaping

Staff provided tobacco and vaping information and Quitline resources to 55 individuals at the Aetna Health Fair held at the Rhythm City Casino. Staff also presented tobacco/vaping cessation education to students at Safer Foundation and to students at MidCity High School through their iJAG program.

Oral Health Education

Staff provided oral health education to 36 students at a preschool and childcare center in Maquoketa. Education and discussion of healthy teeth and hands-on oral hygiene instruction were provided. This effort is part of what is required in the Child and Adolescent Health/I-Smile™/Hawki contract for Collaborative Service Area 14.

Staff was a vendor for the Aetna Medicare Advantage Member Fair. Staff provided I-Smile Silver™ program information, oral health education, and care coordination for in network dental providers. Staff was also a vendor for the CASI Senior Social Services Fair. Program information was shared and education on the link between oral health and overall health was provided.

Medication Administration Skills Competency Training

Staff provided Medication Administration Skills Competency training to 15 childcare providers. The training provides information on the safe administration of medications to children in care, including a skills demonstration for eight different types of medication. For training credit, each

participant completes a one-hour skills assessment within 30 days of the class. For Iowa's quality rating improvement system, skills assessments should be completed every two years. Staff is very busy with this training and associated skills assessments.

Education for Non-Public Schools

Staff completed puberty education for the fourth and fifth grade girls at two of the non-public schools. While department staff presented education to the females, a school staff member presented education to the males. Students were given puberty kits with a booklet relevant to hygiene and body changes, as well as a toothbrush and toothpaste. Another non-public school asked department staff to co-teach one of their health classes which included sex education for their 7th graders. A total of 45 students attended the class and the presentation was very well received by the students, the teacher, and the school principal.

Staff attended the 8th Grade Catholic School Career Day, which was held at St. Ambrose. Staff had a display table and were able to promote careers in healthcare (nursing, dental). Students were able to use a stethoscope for hands on activities, including listening to the heart and lungs. The students were engaged and interested.

Kindergarten and pre-school round-ups at the non-public schools have begun. At these events, staff provide parents/guardians with information on health requirements for enrolling in school, including immunizations, dental screening, vision screening, and lead testing. Education is also offered to parents regarding enrolling students in school who have special health conditions.

Palmer College Vendor Day

Staff participated in the first of two Palmer College Vendor Days. Vendor Day is an opportunity to present the programs and services of the department to the Palmer College students. The vendor table displayed health information and participants were encouraged to utilize available services.

Hand-Only CPR Training

The Quad Cities HEARTSafe Coalition (QCHC) provided a free 30-minute Hands-Only CPR training to the University of Illinois Extension, Coal Valley community members, Quad Cities Links, Milan 4H Club, Scott County Health Department, Augustana College, and RE/MAX Concepts. More than 135 people learned the two important steps to Hands-Only CPR and each organization received a free American Heart Association Family & Friends Anytime Kit with a DVD and mini rescue Annie as a result of these trainings.

Strengthen, support, and mobilize communities, and partnerships to improve health

Initial Meeting with New Genesis Leadership

Mahesh Sharma, County Administrator, and I met with Dr. Kurt Andersen, President of Genesis Health System, for an introductory meeting. While we had both interacted with Dr. Andersen

previously, this was an opportunity to learn about his new role, the vision for Genesis following the merger with MercyOne, and to assure that open lines of communication were established.

Hepatitis C Prevention Focus Group

Staff collaborated with the Center for Behavioral Health to conduct a hepatitis C prevention focus group. The focus group included individuals who have lived experience with current injection drug use, previous injection drug use, and/or individuals who work directly with this population. The desired outcome of this focus group was to gather information that will better inform marketing and service delivery to these individuals.

Healthy Pregnancy Coalition

Staff facilitated a Healthy Pregnancy Coalition interest meeting for Collaborative Service Area 14 (Cedar, Clinton, Jackson, and Scott Counties). The goal of the Coalition is to bring together community members, stakeholders, and partners to help reduce maternal mortality rates and maternal health disparities in the area. Approximately 40 individuals participated in the interest meeting.

Create, champion, and implement policies, plans, and laws that impact health

Discussion of Vape and Tobacco Free Spaces in Riverdale

Staff met with the Mayor of Riverdale to discuss implementing a city-wide ordinance for vape and tobacco free spaces. Another meeting is scheduled for April.

CHANGE Tool Reassessment and Recommendation Presentation

Staff completed the workplace Community Health Assessment and Group Evaluation (CHANGE) Tool reassessment with The Summit of Bettendorf. Over the course of a year, The Summit installed two bicycle racks, began offering a discounted gym membership, and now provides a lactation room. The Summit expressed interest in continuing to work with the department to conduct an employee wellness needs assessment, establish a culture committee, and more.

Staff presented workplace CHANGE Tool results and recommendations to the Ascentra Credit Union leadership team. As part of the process, staff provided an overview of the Community Transformation Program and workplace wellness CHANGE Tool recommendations. Their leadership team will discuss and approve recommendations for their Human Resources team to implement in partnership as part of this initiative.

Augustana College Receives Champion Award

The Tobacco-Free QC Coalition presented Augustana College with a Champion Award for their newly adopted tobacco/vape free campus policy. This campus policy was seven years in the making and was a great achievement in both promoting tobacco and vape free spaces and raising awareness of the harmful effects of both products.

Child Care Provider Linked with Services to Support Licensing

Staff met with staff at a child care center following a referral from the facility's Child Care Licensing Consultant with Iowa Health and Human Services (HHS). During the meeting, concerns regarding cleaning, sanitizing, and disinfecting procedures were discussed and several resources were shared. Follow-up is ongoing.

The last inspection at the Hampton Inn in Clinton was conducted in 2019. Since that time, management had kept the pool and spa closed and the manager had agreed to notify the department if and when it was decided to reopen the pool and spa. Staff contacted the manager periodically to confirm closure. In March, staff stopped at the facility and found the pool open, while the spa was being demolished. Hotel management and ownership had recently changed. The owner and manager were advised to close the pool and obtain a construction permit from HHS to properly decommission the spa. Besides not having a permit, the facility does not have a certified pool operator on staff. The new owner was notified that the pool is to remain closed until all violations have been corrected and staff conducts a reinspection to confirm compliance.

Staff conducted a re-inspection at The Current Hotel for their pool and spa. The facility was initially closed due to outdated drain covers. Those covers have been replaced and the facility reopened.

Assurance

Assure an effective system that enables access to the individual services and care needed to be healthy

Child and Adolescent Health Services Continue

Staff completed a Medicaid presumptive eligibility (PE) application for an individual who recently moved to the state and did not have health coverage. PE provides Medicaid for a limited time while a formal Medicaid eligibility determination is being made by HHS.

Staff provided dental screenings and fluoride treatments to students at seven different elementary schools and five early learning centers in the four counties. Staff continues to provide dental screenings on Wednesdays during the department's immunization clinic.

HIV Outreach Services Provided

Staff provided HIV counseling, testing, and referral services during mobile testing events at Quad City Harm Reduction, Center for Behavioral Health, Pearl City Outreach, Muscatine Center for Social Action, and Goodwill Heartland-Muscatine.

Build and support a diverse and skilled public health workforce

Public Health Conference of Iowa

A number of staff attended the Public Health Conference of Iowa hosted by the Iowa Public Health Association, Iowa Environmental Health Association, Black Hawk County Public Health, Iowa Counties Public Health Association, HHS, University of Iowa College of Public Health, and the University of Iowa Division of Child and Community Health. The conference provided an opportunity to network with public health partners from a variety of sectors and while receiving information on unique programs and projects. Staff attended a variety of sessions, including the following:

- *Transforming Trauma: Current Trends in LGBTQ Health*: Presented by Iowa Safe Schools, this session addressed how to support lesbian, gay, bisexual, transgender and queer/questioning plus (LGBTQ+) youth in a variety of environments, including in health care. The speaker identified how best to address individuals using various pronouns and how to create open conversations. The session also discussed how to support LGBTQ+ youth as new legislation is implemented in schools and other settings.
- *Syndromic Surveillance: Iowa Health Information Exchange*: Representatives from Cync Health and HHS presented on the Iowa health information exchange (HIE) and its role in gathering syndromic surveillance data that is shared with the CDC. At this time, 87 of Iowa's 115 health care systems are enrolled and importing information to the HIE. In a

broad sense, HIE provides a longitudinal view of a patient's records from a variety of providers. It is also providing an almost real-time monitoring of health data for HHS epidemiologists to analyze. As work on the HIE continues, it is anticipated that public health will be given limited access to extract population/community-level data for community health planning efforts.

- *IHHS Update with Director Garcia and Dr. Kruse:* This update provided information on a number of topics related to public health within the HHS system. First, full alignment of the two entities will begin July 1, 2023. The public health division will continue to focus on population health with a new mission, vision, values, and guiding principles. An overview was provided of the HHS organizational chart, highlighting the role Dr. Kruse will play as the Director for the Public Health Division and as the State Medical Director for all of HHS. HHS received a CDC public health infrastructure grant valued at \$35 million over a five-year time period. The funds will be used to hire state level staff, address data modernization and interoperability, and evaluate a regional approach to local public health services in Iowa.
- *Redlined Iowa: Exploring the Legacy of Institutional Racism on Contemporary Health:* This session provided a discussion of the history of redlining in Iowa and the role that real estate professionals, financial institutions, local and federal governments, and homeowners played in the system. Redlining maps for a variety of Iowa urban areas were shared, including for Scott County. Research shows that racial segregation is associated with higher mortality, poor environment, less green space, less access to food, and worse health outcomes, including COVID-19. According to a study by the presenter, if an individual was born in a redlined district, the individual will die 25 years earlier than their neighbor, identifying very strong patterns between today's health outcomes and previous policies and structures that have been put into place. Attendees were encouraged to look at health data, ensure it is disaggregated, and identify ways to implement programs and policies more heavily in redlined areas.
- *Improving Person-Centered Care for LGBTQ+ Innovative Teaching Strategies:* This session was led by Dr. Ann Garton from St. Ambrose and covered work creating the LGBTQ+ Curriculum Toolkit for educators and/or healthcare professionals. Dr. Garton utilized a worksheet from the toolkit to determine how comfortable session attendees were discussing LGBTQ+ issues such as pronoun usage and asking about other health concerns not related to sexual orientation. This activity created a baseline of understanding for how this terminology and focus should be integrated into regular care and how it can be applicable to other settings. Dr. Garton provided an overview of the toolkit and discussed the tools available to health care providers and educators to promote cultural humility and to utilize interprofessional cultural competencies.
- *Birthing Center Closures-The Impact on Rural Iowans and Birth Outcomes:* This session was devoted to discussing the large number of birthing centers that have closed in Iowa

and the impact of the closures. A study completed from 1999-2020 and focused on eight counties found that each county that experienced a hospital closure saw an increase in inadequate prenatal care, and this contributed to negative birth outcomes. The session also included discussion or work that is occurring to help improve the situation for birthing parents using community programs. Count the Kicks, Iowa State University (ISU) and HHS were the presenters.

- *Flip the WHAT? How One Small Local Public Health “FLIPPED” to 100% Population Health:* This session focused on Fayette County and how they reorganized their health department. The presenters provided history of the 14 service areas that were in place within the department and how they were not seeing improvements in population health despite the many resources. They reevaluated what services their county actually needed pre and post COVID-19 and asked who would address this health issue the best. The department decreased from 14 service areas to four; population health, immunization, preparedness, and county funding. They heavily utilized the results from their community health assessment and community health improvement plan and continue to make changes to their department based on those results.
- *African American Men and Prostate Cancer-Understanding Disparities in Prostate Cancer Amongst African American Men in Black Hawk County:* Black Hawk County has some of the highest prostate cancer rates in Iowa. Because of this, Project Health was created to help African American men in the county. Project Health conducted a study to evaluate barriers to prostate cancer screenings, determine where African American men get their health information, and assess knowledge about prostate screening. They found that African American men had insurance, but most were not even being offered screenings or never inquired about screenings. Early detection increases the chances of survival, but African American men were getting diagnosed in later stages. Project Health offers education and help for men to navigate the health care system.

Certified Lactation Specialist

Two Family Health staff completed five days of training and an exam to become Certified Lactation Specialists. During the course, attendees are taught how to use appropriate counseling skills, how to teach birthing parents and families, and how to function as a hands-on clinician.

Oral Health Equity Through Grants Webinar

Staff participated in the webinar, *Advancing Equity Through Oral Health Grantmaking*. Public health agencies spoke about their efforts towards providing equity through different populations. A dentist in the Chicago area spoke about her community-based research and data analysis through a pilot program partnering with federally qualified health centers to help those in need find dental care.

Breastfeeding Webinars

Staff listened to a variety of breastfeeding webinars presented by the Michigan Breastfeeding Network. The webinars included: *Young Parents and the Importance of Breastfeeding; Honoring Indigenous Parenthood from Conception through Postpartum; Lactation and Grief After Perinatal, Neonatal, or Infant Loss; Adverse Effects of Childhood Sexual Abuse on the Breastfeeding Dyad; Human Milk and Immunizations; and Implementing the 10 Steps of Becoming Baby Friendly, Through a Lens of Racial Equity.*

Cross Service Training on Immunizations

Clinical Services staff presented education to the Family Health service area on immunizations in March. The training topics included Scott County immunization audit results, State of Iowa immunization requirements, Vaccines for Children (VFC) program regulations, and immunization services offered at the department. Staff had a meaningful discussion and questions were answered. This training will help Family Health staff navigate immunization questions and needs when working with clients.

Onsite Wastewater Treatment Webinar

Staff attended a virtual Lunch and Learn through the Des Moines Area Community College related to onsite wastewater systems. The topics were lift stations, septic system and lift station design, and septic system control methods. The webinar was the final in a three-part series.

Water Well Chemistry 101

Staff attended the webinar, *Water Well Chemistry 101*. The topics covered included information on water wells, water sampling frequency, elements that can be found in well water, water softeners, and water hardness.

Improve and innovate public health functions through ongoing evaluation, research, and continuous quality improvement

Public Health Preparedness Service Area 5 Exercise and Plan Workshop

Staff participated in the Service Area 5 radiation tabletop exercise. The exercise demonstrated areas where public health would have an active role during a radiological event.

Staff attended the Service Area 5 Local Public Health Point of Dispensing (POD) Plans Workshop. Coalition members discussed essential elements of POD plans, such as Incident Command System structure, security plans, communications plans, job action sheets, flow charts for site set-up, and more. The group also brainstormed ways to consider the needs of vulnerable populations in POD plans. Following the COVID-19 response POD plans are all in need of review and updating based upon after action plans.

Vaccines for Children Program Site Visit

Staff participated in a virtual VFC program site visit with John Fiedler from HHS. These site visits are conducted every other year, however, the department had not had one since 2019 due to

the COVID-19 pandemic. There were no compliance issues identified during the visit.

Build and maintain a strong organization infrastructure for public health

Department Infrastructure Teams

Quality Improvement Council

The Quality Improvement (QI) Council reviewed the QI mini project regarding the department's refrigerator and will be finalizing the project in April. The Council members reviewed assignments to be completed in preparation for the department's PHAB reaccreditation application.

Health Equity Committee

The Health Equity Committee hosted a presentation on housing, one of the social determinants of health (SDoH), at the March All Staff meeting. The presentation was given by the Quad City Housing Council. Committee members provided an introduction to the SDoH to staff and provided insight into recent data on the impact of SDoH on health in Scott County. The committee continues to work on health equity in action projects, including health equity content for the department's website, identification of an All Staff health equity training, and recommendations for visual displays to promote inclusion in the department's clinic space.

Legislative Committee

The Legislative Committee has continued to monitor legislation at the state level. In the past month, the committee sent education to Scott County legislators regarding raw milk and home food/cottage industries/food freedom. The BOH's position statement on raw milk was shared with the legislators as well. The committee continues to learn more about the legislative process during this extremely busy legislative session.

Workforce Development Committee

The Workforce Development Committee received initial data from the University of Iowa College of Public Health regarding responses to the Workforce Development Assessment that was completed by all staff in January/February. A full report is anticipated in early April for review. The Committee discussed arranging the new employee orientation process according to the 10 Essential Services of Public Health. This initial idea will continue to be developed, but has the potential to connect the pieces of orientation to the big picture of public health. With many new staff members having very little public health experience, an overview of public health will be included in the orientation process. Committee members are reviewing several public health 101 courses available to determine whether they would be beneficial for new staff to complete.

Workplace Culture Committee

The Workplace Culture Committee discussed items to recommend to the Workforce Development Committee for inclusion in the New Employee Orientation process that is being developed. The Committee also began discussion on the logistics that need to be considered for the all staff full day training that will take place in August. This event will be focused on

understanding ourselves and others as we continue to build the department and establish its culture.

Health Promotion Team

The Health Promotion Team has formed a subcommittee to work on a Health Promotion Strategy for National Infant Immunization Week, which occurs the last week in April. Staff will seek feedback on the strategy and associated materials from department immunization clinic clients, WIC clients, LULAC, and St. Anthony clients.

The Health Promotion Team also prepared for the promotion of National Public Health Week, which took place the first week of April. The Board of Supervisors recognized a proclamation regarding the week, an article was written in the April edition of the Public Health Connection, and social media messages promoting the daily themes were shared.

Team members also reviewed assignments to be completed in preparation for the department's PHAB reaccreditation application.
