Assessment

Assess and monitor population health status, factors that influence health, and community needs and assets

Opioid Settlement Steering Committee

The Opioid Settlement Steering Committee met in November to discuss the status of the core strategies within Scott County (do they exist, are they consistently occurring, etc.). The core strategies of the settlement have a strong evidence base supporting their effectiveness and include:

- Broaden access to naloxone;
- Increase use of medications to treat opioid use disorder;
- Provide treatment and supports during pregnancy and postpartum period;
- Expand services for neonatal opioid withdrawal syndrome;

- Fund warm hand-off programs and recovery services;
- Improve treatment in jails and prisons;
- Enrich prevention strategies;
- Expand harm reduction programs;
- Support data collection and research.

Additional focus groups were held during November with the following subpopulations: individuals at the jail, healthcare/emergency department providers, youth, and older adults. The Core Team also reached out to providers who work with the pregnant and postpartum population, but opioid use was not perceived as a significant issue among this population. A final large group meeting will be held in January to prioritize which core strategies to focus on for initial recommendations to the Board of Supervisors.

2024 Community Health Assessment Planning Continues

Staff attended the Community Health Assessment (CHA) Steering Committee meeting to continue planning discussions for the 2024 CHA. The group is determining which additional types of surveys to include in the assessment to gather more qualitative data to complement the quantitative survey to be completed by Professional Research Consultants (PRC).

Investigate, diagnose, and address health problems and hazards affecting the population

Communicable Disease Program

A total of 11 confirmed communicable diseases were reported during November. They included six cases of hepatitis C, three cases of hepatitis B, and two cases of campylobacteriosis.

Rabies Risk Assessments

In November, 23 individuals required rabies risk assessments after exposures to 17 dogs and 6 cats. Twelve victims were recommended for rabies prevention treatment for high-risk exposures or bites above the shoulders and three victims started the treatment.

Childhood Lead Poisoning Prevention Program

In November, there were eight children receiving individual lead case management. Of those, six had a blood level less than 15 ug/dL, two had a blood lead level between 15-19 ug/dL, and none had a blood lead level between 20-44 ug/dL. Seven children with an initial blood lead level between 10-14 ug/dL received supportive services (visual inspections, education over the telephone, appointment reminders) for lead poisoning during the month. Of those, three had a blood lead level between 10-14 ug/dL and four had a blood lead level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 3.5 ug/dL are obtained.

Sixteen children utilizing the department's immunization clinic accepted lead testing services at their November appointment. Seven children were under three years of age and nine were ages three and older. No children accepted testing services at WIC. There were no new positives identified during these efforts.

In November, the Food and Drug Administration (FDA) issued a nationwide recall of all lot

numbers of WanaBana Apple Cinnamon Fruit Puree due to excessive lead levels in the product. The product was sold at Dollar Tree locations and states were instructed to conduct audit checks to assure that all products were pulled from the shelves. Staff visited the five Dollar Tree locations in Scott County, and all had pulled the product from the shelves pending further notification from Dollar Tree corporate. Staff completed and submitted the required paperwork to the state.

Sexually Transmitted Disease Program

Sixty-three individuals received sexually transmitted infection (clinic) services during November. Five clients tested positive for chlamydia, two clients tested positive for gonorrhea, and one client tested positive for syphilis at the Health Department's sexual health clinic. In total, 69 cases of chlamydia, 22 cases of gonorrhea, and three cases of syphilis were reported in Scott County during the month. There were 21 additional syphilis results and three HIV results that were investigated and determined to be out of jurisdiction, not identified as a case, or had a pending case. These cases were closed, referred, or remained open pending additional results.

Policy Development

Communicate effectively to inform and educate people about health factors that influence it, and how to improve it

Oral Health Presentations

Staff presented to the Delta Dental of Iowa Foundation board regarding I-Smile™ Silver work with Scott County veterans. Since September 2020, Scott County's I-Smile™ Silver coordinator has worked with Scott County Veteran's Affairs to secure \$153,245 of oral health care for veterans through the Iowa Veteran's Trust Fund. These dollars go to local dental providers that are willing to assist the veterans and follow program requirements.

Staff presented oral and systemic health information to 21 Palmer Hills Senior Living residents and 17 seniors at Friendly House. Seniors received basic information they could use, and oral hygiene supplies customized to their needs. Participants were able to linger and discuss questions and concerns after the presentation.

Staff completed training for two school nurses in the Camanche Community School District. Training included how to perform dental screenings and when to refer for care. Information was also shared regarding Iowa Dental Audit requirements.

Presentation on E-Cigarette Recycling

Staff was invited to attend River Action's RiverWay Steering Committee meeting to present the e-cigarette disposal protocol developed in partnership with the Waste Commission of Scott County, discuss the environmental danger of these products, and explore ways for River Action to be involved in associated efforts.

Strengthen, support, and mobilize communities, and partnerships to improve health

Updates to Maternal, Child, and Adolescent Health Collaborative Service Area Partners

Staff attended the Clinton County Board of Health meeting virtually and shared an update about the Child and Adolescent Health, I-Smile™, and Healthy Pregnancy/Maternal Health Programs. Board members expressed concerns over obstetrics/gynecology providers leaving the area and potential challenges that pregnant patients may face when trying to access prenatal care and delivery services in Clinton County.

Staff presented to the Clinton-Jackson Early Childhood Iowa (ECI) Board at their November meeting. Updates were shared regarding staffing, service numbers, children at risk for tooth decay, and locations served. The second year of the program appears to be off to a great start with more than 175 children served at eight locations in just the first two months of programming. Clinton-Jackson ECI provides supplemental funding to support screening and education in preschool and child care centers to expand the reach to children beyond I-Smile™.

Isle of Capri Joins Local Food Rescue Efforts

Isle of Capri food service staff learned about food waste trends, local food insecurity, and the Good Samaritan Food Donation Act during the Food Rescue Partnership presentation at the department's fall ServSafe class. In September, the Isle of Capri contacted the department to discuss their interest in donating food to a non-profit hunger relief organization. After research, the Food Rescue Partnership facilitated a meeting with the Isle of Capri and Yolanda Jefferson, Chefy Bear on Wheels, to begin food donations. The first food donation was coordinated in November and will continue monthly.

Create, champion, and implement policies, plans, and laws that impact health

Follow Up on CHANGE Tool Assessment Recommendations

The Eldridge City Administrator met with staff to review the community-at-large Community Health Assessment and Group Evaluation (CHANGE) Tool report and recommendations. The city administrator expressed interest in proposing several identified recommendations to the Eldridge City Council in early 2024.

Staff met with Jean Hansen, QCR Holdings, to review the workplace CHANGE Tool recommendations. During the meeting, Ms. Hansen expressed interest in presenting a variety of recommendations to the internal wellness committee for input.

I-80 Mississippi River Bridge May Include Pedestrian/Bike Access

Staff and I attended the I-80 Mississippi River Bridge led by the Iowa and Illinois Departments of Transportation (DOT) and Federal Highway Administration (FHA). After several assessments, DOT and FHA indicated that preferred bridge location alternative five is being recommended for implementation because it will result in the least number of relocations (homes, businesses) and smallest wetland impact. During the presentation, the DOT and FHA acknowledged a strong interest in safe pedestrian and bicycle access throughout the series of public input sessions. The lead organizations will continue meeting with the cities of LeClaire and Rapid City to discuss feasibility and ongoing maintenance for pedestrian and bicycle access on the I-80 Mississippi

River Bridge. It is not common to add pedestrian and bicycle access to interstate bridges, but partners are open to further discussion.

Utilize legal and regulatory actions designed to improve and protect the public’s health

Food Program

Staff were dispatched to Raising Cane’s on 53rd Street in Davenport after being contacted by the Davenport Fire Department regarding a small fire. The business disposed of all open products and supplies near the area of the fire and conducted thorough cleaning and sanitizing in the affected area and was able to re-open on the same day.

During the Thanksgiving holiday weekend, the department received a complaint relayed from the Davenport Police Department regarding drain issues and sewage back up in the bar and dining room at the Applebee’s on Elmore Avenue in Davenport. On the recommendation of the department, the restaurant voluntarily ceased operation until necessary work was completed. A physical re-inspection was conducted on December 1 and the facility was granted permission to re-open as plumbing work was complete.

A similar complaint was made about the Pizza Hut on West Kimberly Road in Davenport where the facility was experiencing plumbing issues, and was unable to properly wash, rinse, and sanitize dishes using a mechanical dish machine. The facility did not have another effective means to wash dishes and was advised to cease operations. Plumbing work at the facility is not yet complete, and the facility remains closed.

Swimming Pool/Spa Program

Staff met with John Kelly, Iowa Department of Inspections and Appeals (DIAL) Environmental Engineer, for an assessment of the condition of the pool facility at The Ramada by Wyndham in Bettendorf. The pool has been closed for several years and the owner intends to reopen it. Mr. Kelly found a substantial number of safety hazards, many of which were the result of modifications made without a state reconstruction permit. He provided the owner with a comprehensive report detailing the issues that need to be resolved before the facility can reopen. In his report, Mr. Kelly advised the owner that no formal legal enforcement will be taken at this time for the prior construction. If the facility reopens without a state permit and the correction of all violations, further action will be taken by DIAL.

Staff also accompanied Mr. Kelly on a pre-opening pool inspection for the new Courtyard by Marriott in Bettendorf. Staff completed the follow-up physical re-inspection needed for the facility to obtain licensure from DIAL.

Assurance

Assure an effective system that enables access to the individual services and care needed to be healthy

Community Dental Screenings, Education, Fluoride Treatment, and Care Coordination

Members of the department's I-Smile™ team provided dental screenings, education, and fluoride treatment to children at several community locations including two Head Start programs, three preschools, and nine elementary schools within the Child and Adolescent Health Collaborative Service Area (Cedar, Clinton, Jackson, and Scott Counties). Following the screenings, the team provides care coordination services to link children with identified needs to a source of oral health care.

Staff worked with an adult client identified at St. Anthony's Church outreach to find a dentist who is in network with their Medicare Advantage plan. In addition, staff provided directions on how to apply for Iowa Medicaid in hopes of dual enrollment. The client needed a new set of dentures and was able to get them without any out-of-pocket costs.

Non-Public School Health Screenings

Staff conducted health screenings at three non-public schools during November. Eighty-two kindergarten students received dental screenings and 487 students received vision screenings. Thirteen students were referred for a dental evaluation and 62 were referred for a vision evaluation. Three kindergarten students were referred for urgent dental care. Screenings will continue with the rest of the non-public schools in December.

MEDIC EMS of Scott County

The MEDIC EMS Board of Directors and the Scott County Board of Supervisors both approved and signed the Asset Transfer Agreement; the final legal transaction between the two entities making MEDIC EMS a unit of Scott County government on January 1, 2024. The MEDIC EMS Board has also approved additional dissolution documents and will have one staff person and one board member to finalize operations after December 31, 2023. In November, MEDIC EMS of Scott County received its Medicare certification letter following the very first Medicare site visit at MEDIC EMS headquarters. Based upon the tasks tracked in the Transition Team's workbook, 53 percent of the items are completed, 43 percent are in progress, and four percent are not started. The team continues to meet weekly to provide updates, discuss issues that have arisen, and to offer support to each other.

Build and support a diverse and skilled public health workforce

Tobacco Community Partnership Conference

Staff attended the Tobacco Community Partnership Conference where they reviewed the successes of Scott County tobacco control efforts and learned how to further Iowa Students for Tobacco Education and Prevention (ISTEP) chapter development, smoke free policies, and how to address the extensive list of new e-cigarette products. Attendance at this event is a contract requirement.

Homeland Security Exercise and Evaluation Training

The Preparedness Team attended the Homeland Security Exercise and Evaluation Program training via the Scott County Emergency Management Agency. The information gained will help the team to better understand, develop, and implement a consistent and beneficial preparedness exercise program.

"Pink Book" Immunization Conference

Staff attended the two-day CDC "Pink Book" Immunization Conference. The "Pink Book's" official name is *Epidemiology and Prevention of Vaccine-Preventable Diseases* and provides comprehensive information on routinely used vaccines and the diseases they prevent. Four presenters from the CDC discussed safe storage and handling of immunizations, general best practices used with immunizations, and safety procedures used during immunization administration. In addition, each of the vaccine-preventable diseases and available immunizations were discussed. There were opportunities to connect with other immunization providers in Iowa, including the Iowa Immunizes Coalition and state HHS contacts.

Iowa Department of Natural Resources Private Well Training for New Sanitarians

Staff attended the Iowa Department of Natural Resources' virtual Private Well Training for New Sanitarians. The training addressed permitting, Grants to Counties funding, well drilling methods, types of wells, agriculture, irrigation, well sampling, and well abandonment.

emPOWER and Social Vulnerability Index Data Sharing Workshop

Staff attended the Service Area 5 Healthcare Coalition emPOWER and Social Vulnerability Index (SVI) Data Sharing Workshop. This federal HHS data illustrates the region's Medicare beneficiaries and electricity-dependent populations and can be helpful for preparedness

planning at the local and regional level. The workshop attendees discussed which at-risk/vulnerable populations the region wants to incorporate into planning to fill gaps. Some of the top choices were adults with chronic conditions, the non-English speaking population, and the homeless/transient-housing population. The department did access emPOWER data through the state during the 2020 derecho response. There are multiple steps, including agreements and security protocol acceptance, that must be completed prior to obtaining person-specific data.

Leadership Movie Club

Staff attended the Leadership Movie Club session for the movie, *Invictus*, facilitated by Donna Honold and Chris Battell. *Invictus* tells the story of Nelson Mandela stepping into his role of President of South Africa and facing the challenge of unifying a country still reeling from years of apartheid. He joined forces with the captain of South Africa's rugby team, Francois Pienaar, to help unite the country using the universal language of sport. This session focused on leading teams using two leadership models: *The Five Dysfunctions of a Team*, by Patrick Lencioni and *Teamwork: What Must Go Right, What Can Go Wrong*, by Larson and Lafasto.

Childhood Lead Poisoning Program and Workgroup

Staff and I attended the virtual Childhood Lead Advisory Workgroup session. This session was a joint update between the Childhood Lead Advisory Workgroup (CLAW) and the HHS Childhood Lead Poisoning Prevention Program (CLPPP) and its local contractors. CLAW meets quarterly and includes representatives from state government organizations, health care, education, local public health, and other community partners. Annually, the meeting expands for educational purposes and to share program updates. Attendees learned about performance measures and a new remote visual risk assessment tool for conducting inspections. CLAW has been working on blood lead testing guidelines and launching housing policy subgroups this fall. County Lead Report Cards were reviewed, and attendees were asked how to better utilize them to communicate data on lead testing and populations at risk of lead exposure.

Silver Diamine Fluoride Presentation

I-Smile™ Program staff attended a training about silver diamine fluoride (SDF) and other fluoride products. The training reviewed physical properties of the products and how best to apply them in public health settings. The training was hosted by Elevate Oral Health and the presenter was Melinda Crawley, a dental hygienist and preventive health consultant with the product company.

Listening Visits Session

Staff attended a Listening Visit Engagement Session with other Maternal Health/Healthy Pregnancy grantees, state staff, and staff from the University of Iowa. Participants reviewed the basic tenants of listening visiting and observed or participated with role-playing listening visit conversations. Listening visits are a non-directive counseling intervention delivered by nurses. They are used in the department's Maternal Health/Healthy Pregnancy Program for pregnant or postpartum patients, particularly if there is an identified need for support and a delay in connecting the client with mental health services.

Emotional Intelligence Training

Staff attended the Scott County Leadership Summit training on Emotional Intelligence with Donna Honold and Chris Battell. Participants learned that developing emotional intelligence begins with having a greater understanding of one's own emotional brain and how it influences behavior and decision making in response to events. Competencies that help support an emotionally intelligent team include being present, empathetic, genuine, expansive, resilient, and empowering.

Recognition of Child Sexual Abuse Training

Staff attended Stewards of Children training to help recognize the signs of child sexual abuse and how to respond if they do report a case of sexual abuse. The training was delivered by the non-profit Darkness to Light, an organization committed to empowering adults to prevent child sexual abuse.

Improve and innovate public health functions through ongoing evaluation, research, and continuous quality improvement

Quality Improvement Project: Food Program 2023 Risk Factor Study

Members of the department's Quality Improvement (QI) Council are working with department Food Program staff on the Food Program 2023 Risk Factor Study. The goal of this QI project is to identify ways to reduce the incidence of the most frequently occurring risk factor violations. This is best practice and is outlined in the FDA Retail Food Program Standards. The group met once during November to examine the violation data and to engage in a focused conversation around what is occurring currently at the intervention level.

Third Quarter Community-Based Screening Services Quality Report

The department's Sexual Health Program received the 2023 Third Quarter Community-Based Screening Services (CBSS) Quality Report. There was a 3.5 percent increase in testing among the CBSS test sites across the state in the third quarter compared to the second quarter. The positivity rate for chlamydia increased from 6.9 percent to 7.3 percent in the third quarter. The positivity rate for gonorrhea decreased slightly from 3.3 percent to 3.0 percent, and the positivity rate for trichomoniasis decreased from 6.2 percent to 5.5 percent in the third quarter.

Adjustment to Department's Social Media Posting

The Social Media Team is currently working to update the department's social media posting process. After meeting with staff from Dallas County and Black Hawk County Public Health Departments, the team has decided to take a campaign style approach, focusing on sharing multiple posts on a few key public health topics each month. The team anticipates starting the new process in January 2024.

Quality Assurance Inspections Continue

The Food Inspection Team completed three quality assurance inspections during the month of November. Quality assurance inspections are required for regulatory programs that are enrolled in the Retail Regulatory Food Program Standards; Standard 4 addresses requirements related to having a uniform inspection program.

Build and maintain a strong organization infrastructure for public health

Department Infrastructure Teams

Quality Improvement Council

The QI Council presented the Five Why's QI tool at the November All Staff meeting to familiarize staff with the tool for use in their work. The council reviewed the status of the customer satisfaction surveys for each service area, assigned staff to work with the Fiscal and Correctional Health teams, and continued its work on revising the department's QI Plan.

Health Equity Committee

The Health Equity Committee is currently planning for a health equity discussion at the December All Staff meeting. This will involve providing an overview of the results of SCHD's first health equity assessment, including the themes and next steps identified by the committee:

- Focus on outreach/engaging the community;
- Opportunities for education/training;
- Prioritizing health equity work at the department level.

Additionally, two Health Equity Committee members that have experience in engaging communities in program planning and implementation will answer questions about how to plan these activities and challenges that they have encountered in the past. The vision is to provide tangible examples of how this work can and does occur, to increase the frequency in which the community is engaged by staff.

Health Promotion Team

The Health Promotion Team has been working on COVID messaging to be displayed in the interior of the Citibus buses as well as at bus shelters throughout Scott County. The team is also working with OnMedia to promote COVID messaging throughout the community. A background template featuring the SCHD brand was created to be used when utilizing Zoom, WebEx, or other online platforms for virtual meetings. This will be an option for staff to use when presenting or meeting virtually. The team also began reviewing the PHAB assignments in preparation for reaccreditation.

Legislative Committee

Members of the Legislative Committee continued work on the development of the department's Legislative Plan. This plan will formalize the operations of the Legislative Committee and describe efforts undertaken by the department to engage in policy work. The committee also discussed items to be developed/included in an introductory packet for local elected officials as well as a welcome back to session packet for state legislators. Finally, the committee is collecting and reviewing legislative priority documents from the Iowa Public Health Association, Iowa Environmental Health Association, Iowa State Association of Counties, and the Urban County Coalition to identify areas inside and outside of public health that may have public health impacts.

Workforce Development Committee

The Workforce Development Committee reviewed the group's workplan and discussed training that would be beneficial for the department as it relates to the Public Health Sciences core competency. The committee is planning an activity at the December All Staff meeting that will introduce or reintroduce the 10 Essential Services to the department and reflect on the way the department has implemented them during 2023. In addition, the committee is recommending a change in the way that service area updates are provided at the All Staff meetings. Instead of a quick listing of activities going on, a short overview of a program or component of a program, will be shared in an effort to increase knowledge regarding operations across the department.

Workplace Culture Committee

The Workplace Culture Committee chose two themes identified during the Joy in Work discussion, held as a part of the department's August All Staff Education Day, to focus on during 2024. One of the themes was based upon what brings joy and the other theme was based upon what gets in the way. The committee will host focus groups with staff to better understand the specifics of the themes identified and to identify ways to build on the positive and address the negative. The committee also discussed ways to continue to share information on DISC profiles. While much of the work to understand each other is done individually or within teams, the Workplace Culture Committee will continue to provide opportunities for learning to support the department.
