CPSC Recalls

MAY 2014



The Consumer Products Safety Commission (CPSC) regulates the sale and manufacture of more than 15.000 consumer products. The CPSC is committed to protecting consumers and families from products that are unsafe and pose a risk for injury or death. Products include toys, cribs, equipment, bicycles, and many of the household items you use every day. The CPSC recalls unsafe products and alerts the public however in a recent report by Kids in Danger, an organization devoted to children's safety and recall awareness, found that only

10% of recalled kids products are repaired, replaced or refunded. According to CPSC when an unsafe product is recalled, companies have 3 options for consumers: refund, replacement, or repair. Unfortunately, many times parents, grandparents, caregivers, and consumers are not aware of the recall or don't take action to respond to the recall. Although it is illegal to sell a recalled product, often unknowingly recalled products are sold at garage sales, thrift stores, and on websites. In 2013, 13 recalled toys/equipment were found in use in Clinton and

Jackson child care sites.
Child Care providers are encouraged to sign up for Free CPSC Recall Alerts at www.cpsc.gov and to avoid purchasing used toys and equipment without first checking if the item has been recalled. Concerned? Contact your local child care nurse consultant for a free toy and equipment check.

concentrations were changed and all liquid acetaminophen products for children under the age of 12 are now being manufactured and sold in the 160mg/5ml strength. The "old" infant drops that were 3 times the strength of liquid acetaminophen are no longer available. However liquid ibuprofen (Advil®, Motrin® and other brands) are still available in infant drops in 40mg/1 ml. Unfortunately there is still some confusion regarding correct dosage for both acetaminophen and ibuprofen used for pain and reducing

your care is to do the following:

Fever and Pain Medication Dosing

- All medications must be in their original container with the label intact.
- All medications should be labeled with the child's name.
- * Do not give medications that are expired.
- Read all medications labels for correct dosing amounts per age/weight of the child.
- Use correct dosing devices (i.e..: oral syringe, medication spoons with dosing marks).
- Keep all medications out of reach of children.
- A parent/guardian must completely fill out and sign a medication report form.
