# Don't wait, vaccinate! Tdap booster is now required in Iowa.

Schools out! Time for carefree summer fun until the next school year. Right? Well, not to squash those summer daydreams, but these summer months are sure to breeze by. The Scott County Health Department (SCHD) encourages you to take advantage of those lazy summer days and get a jump start on your back to school list. Begin with items required for school enrollment, particularly immunizations.

lowa requires immunizations for students entering kindergarten and those enrolled in preschool or daycare centers who do not have a medical or

religious waiver.
Beginning with the 2013/14 school year, lowa law will also require all students entering, advancing, or transferring into 7th

7th grade Tdap immunization is now required!

grade and born on or after September 15, 2000 to have proof of an adolescent Tdap booster immunization. This is a requirement for **both** public and private school enrollment.

## What is Tdap?

Tdap is a booster vaccine for older children, adolescents, and adults. It safely protects against three dangerous

diseases: tetanus, diphtheria, and pertussis (whooping cough).

# Why the new requirement?

Prior to this change, lowa was one of only ten states that did

not have a Td or Tdap vaccine requirement for secondary school. This new requirement will help protect your child, and others in schools and the community, from whooping cough. Whooping cough is a serious disease that causes coughing fits that can last for months. In recent years, whooping cough has been increasing in the United States and in Iowa. In 2012, whooping cough was widespread in Iowa with approximately 417% more individuals with pertussis disease compared to the average of the past five years. Similar increases have been reported in Scott County for the last several years.

# SCHD has been working to make this an easy transition!

Over the past several months, SCHD provided Tdap vaccine clinics in

participating area schools for students in 6th through 12th grades. All students were offered vaccine, regardless of insurance status. Vaccine was offered In order to prevent outbreaks from

occurring in our community as well as to help parents comply with the 2013/14 school requirement. Tdap clinics were held in December and April. Over 1,200 adolescents were vaccinated. Student immunization records were updated and entered into the Iowa Immunization Registry Information System (IRIS). Staff also entered immunization records of students who had already received Tdap and who sent the SCHD a copy of their immunization record. Nurses reviewed each record, signed, and stamped each certificate as updated. Updated certificates were sent to the schools for their records.



## **Access Your Immunization Records Instantly!**

Are you looking for proof of your teen's Tdap booster vaccination, and not quite as organized as you would like to be? Look no further! lowa's Immunization Registry Information System (IRIS) now has a Public Immunization Access Portal. If you live in lowa, and received immunizations by a provider who uses IRIS, then you may be able to access your record with the

click of a button. To search for your teen's record, you must enter your full name, birth date, and social security number or Medicaid ID. If the provider has not recorded your teen's social security number or Medicaid ID in IRIS, you will not find your teen's record. If you cannot access your record on IRIS you may call the Scott County Health Department at 563-326-8618 for assistance in obtaining your record.
