Back to School Immunizations

NOW is the time to get your child's school immunizations.

It's summertime; who wants to even think about getting ready for school? Actually, July is a VERY GOOD time to make an appointment and avoid the last minute rush at your doctor's office. Waiting until August to get your child vaccinated may result in your child not being able to start school on the first day. Many healthcare providers are overwhelmed with phone calls from parents trying to get their children appointments for school immunizations. Every year there are many providers who find themselves unable to see all the children before school starts.

Schools in Iowa are required by law to exclude children who do not meet minimum immunization requirements. This is preventable by planning ahead and getting your child immunized now instead of waiting and trying to get an appointment—or worse yet, being told there are no appointments available.

Your medical provider can help you ensure that your child is ready and has the proper immunizations required in order to start school. Children in 7th, 8th, 9th, 10th, 11th or 12th grade MUST have a Tdap and Meningitis (MCV) vaccination in order to go the first day—so check with your doctor and make sure they are ready!
