# German-American Heritage Center Emigration Story

The second story of the German-American Heritage Center at 712 West Second Street is now open. On Tuesdays and Sundays from -1-4 PM, you can visit a 48 panel exhibition regarding the experiences of immigrants leaving Germany and Eastern Europe for the United States. The exhibit will be here until the end of the year.

Hamburg, Germany, was the main port for immigrants. Many families were separated because of by illness and had to wait in camps until the ships sailed. Then they were put in steerage while first class passengers were allowed to walk the decks. When the Lusitania sank, many of the steerage passengers drowned. Come and see this vivid exhibit!
