

### St. Marks Lutheran Church~

Sue Rekkas will offer a presentation about the Jennie Gilchrist. On October, 28th 1881 a little after 10 pm, the steamer

Jennie Gilchrist left shore with 13 passengers and a crew of 16 men on board. She had in tow one barge and one flat-boat. The latter was being pushed at the bow of the steamer, while the barge was fastened to the port side. She passed through the bridge and had proceeded about a half-mile. At 10:30 pm the engineer discovered the rod used to reverse the wheel was broken, the boat began drifting rapidly down the stream which was swollen by the floods. 16 people died.

Pastor Travis Fisher of St. Marks Lutheran Church will also be giving a presentation about the church itself as well as the original stained glass windows. As a real treat we will also have some music provided by organist Ellen Bowin of St Marks Lutheran Church.
