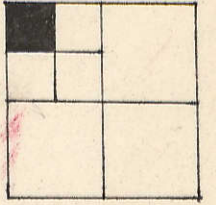

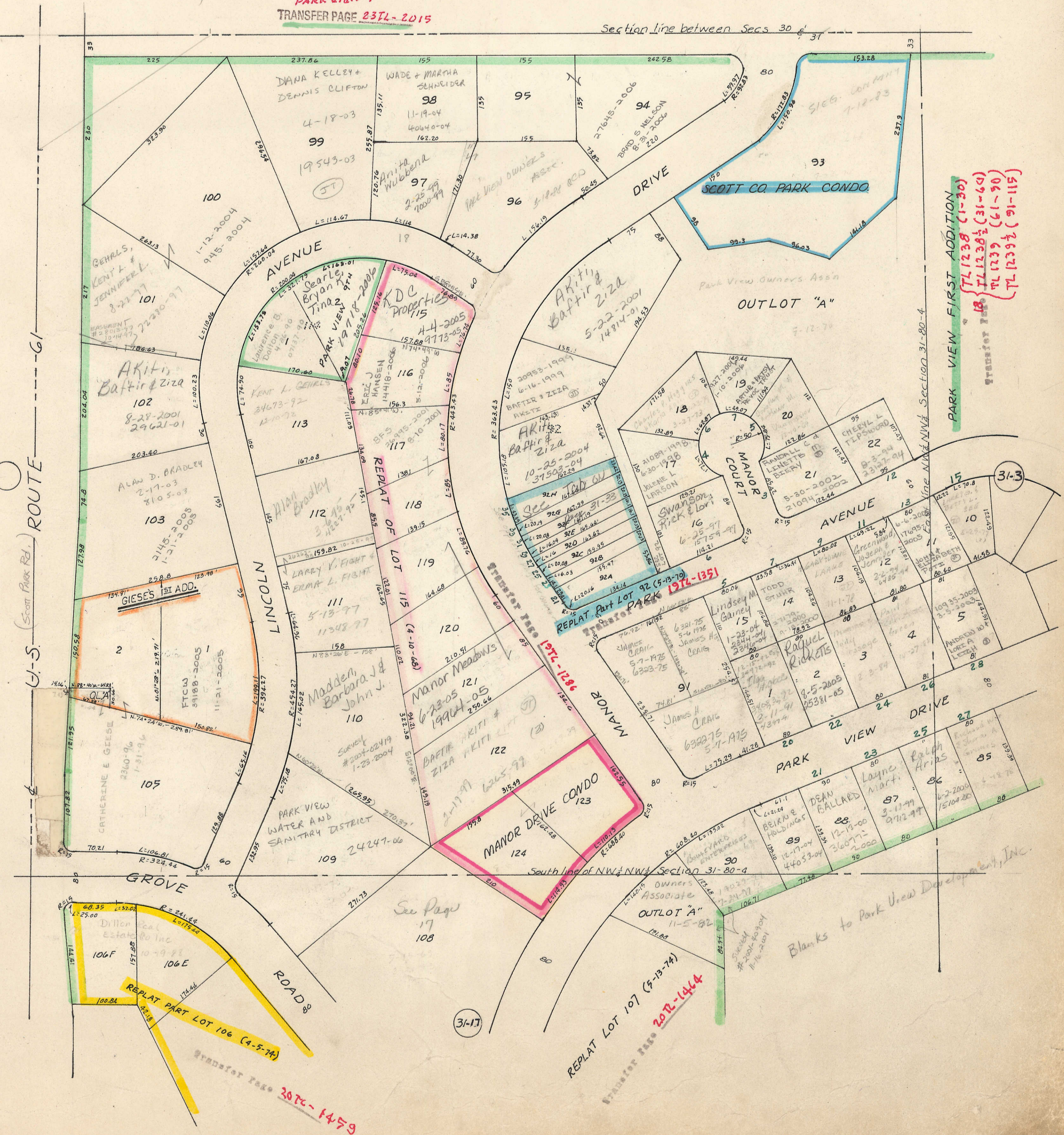


PARK VIEW 9TH
