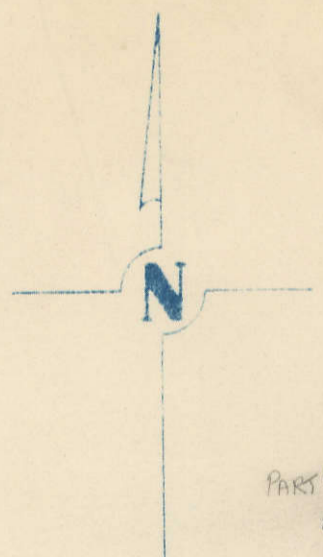

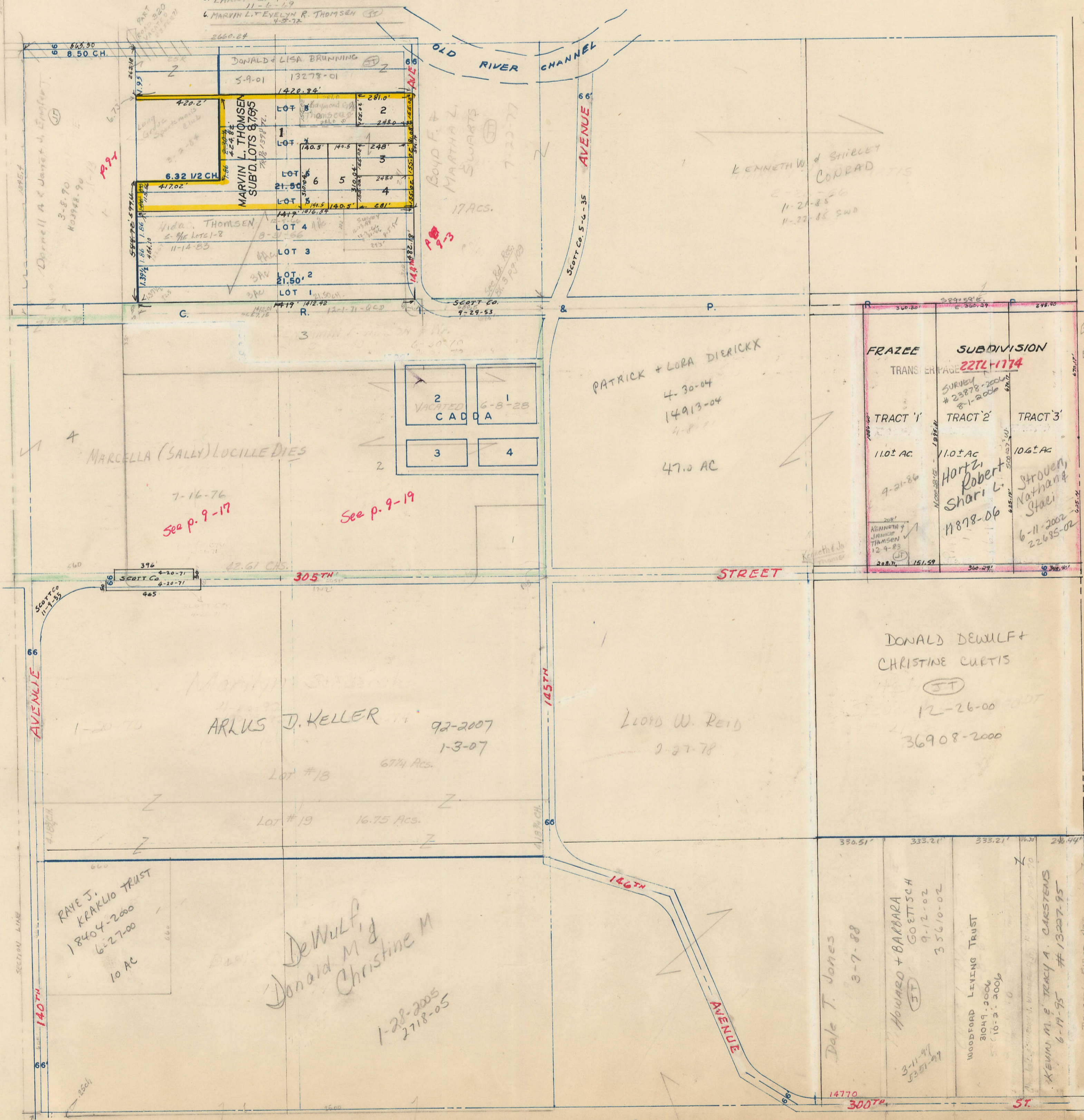


Transfer Map 1898 TL.
