What is Hazard Mitigation?



“Any sustained action taken to reduce or eliminate long-term risk to human life and property from hazards.” (44 CFR § 201.2)

What is Hazard Mitigation Planning?



A coordinated process used by state, local, tribal and territorial governments to identify their risks and vulnerabilities associated with natural disasters and to develop and implement strategies to reduce or eliminate long-term risk.

Why Create a Hazard Mitigation Plan?

- ❑ Disaster Mitigation Act of 2000
- ❑ Allows communities to be eligible for FEMA Hazard Mitigation Assistance Grant Programs
- ❑ Update to the current Hazard Mitigation Plan
 - ❑ Will conform to Federal Regulations found in 44 CFR 201.6

Benefits of Hazard Mitigation Planning

- ❑ Saves lives and reduces risk from future disasters.
- ❑ Aids risk-informed decision making for the whole community.
- ❑ Prepares states and communities to adapt to changing conditions.
- ❑ Helps directed mitigation resources to where they are most needed.
- ❑ Increases capacity to support faster disaster recover.

2018 Scott County Plan



- Was approved by FEMA June 25, 2018.
 - Five Year Plan.
 - Expires 2023.
- What does that mean?
 - Time to start updating!

Grant Application and Funding

- Scott County applied Pre-Disaster Mitigation planning grant, delayed award, notified of award 5/17
- Contracted with Bi-State Regional Commission for planning services. Working under existing member agreements to move forward.

Grant and Local Match

Total Project Cost: \$40,000

- 56% FEMA Grant: \$22,500
- 7.5% State Contribution: \$3,000
- 36% Local Match: \$14,500

 - Provide updated information
 - Review planning documents
 - Assist with public input (Board/Council Agenda item for public input opportunity)
 - Adopt the plan

- ⦿ Community Meetings
- ⦿ Public Meeting for Draft Review
- ⦿ City Council/School Board Meetings for Adoption
- ⦿ May include additional large group meetings to build consensus on plan changes

Timeline of Planning Process

- ◎ Phase 1 (January 2022 – June 2022)
 - Research Hazards
 - Risk Assessment for each community
 - Hazard Priorities
- ◎ Phase 2 (June 2022 – September 2022)
 - Goal Review
 - Mitigation Actions
 - Evaluate Mitigation Actions
- ◎ Phase 3 (September 2022- December 2022)
 - Finalize Draft
 - Formal Public Review of Planning Document
- ◎ Phase 4 (December 2023 – June 2023)
 - State and FEMA Review and Approval
 - Community Adoption

Public Input

- ⦿ Very Important part of the planning process
- ⦿ Ideas:
 - All meetings will be open to the public
 - 30-day comment period before plan is submitted to FEMA
 - Any additional ways to get public input?
 - Survey?
