1. Call to Order: Vice Chairman Knobbe called the meeting to order at 7:00 P.M.

2. <u>Minutes</u>: Consideration of September 28, 2016 meeting minutes. Portes made a motion to approve. Seconded by Scheibe. Vote: All Ayes (5-0)

3. <u>Annual Joint Meeting</u>: Members of the Boards and Commission exchanged words of appreciation for each other's careful research, consideration, recommendations, and decisions, citing the efficiency and consistency of their respective development request proceedings.

**Huey** pointed out that it may be beneficial for the Planning and Zoning Commission to revisit the Future Land Use Map by initiating a township-by-township study to identify current and future development trends. **Earnhardt** asked how long Huey anticipated the process taking. **Huey** said

he anticipated a three (3) to four (4) month study with the Planning and Zoning Commission, and that he expected universal support of continued agricultural preservation, both institutionally and in the Scott County community as a whole.

**Dittmer** discussed his long-established interest in the planning process for unincorporated Scott County, describing the devotion to agricultural preservation he shares with the County's original and evolving Zoning Ordinance and Comprehensive Plan. He highlighted the importance of his and Commissioner Schnekloth's backgrounds as farmers, reminding those attending that society is getting further removed from where its food comes from.

The Industrial-Floating (I-F) Zoning District was brought up by a number of those present. **Huey** said the likelihood of an appropriate proposal to utilize the I-F zoning being submitted was remote, and if/when a proposal is submitted, the public, Planning and Zoning Commission, and Board of Supervisors have a format in which to favor or oppose it. **Huey** made mention of the land available in the Eastern Iowa Industrial Center, saying that area is presently ready for industrial development.

4. Adjournment: With no further comments and no other business to discuss, Vice Chairman Knobbe adjourned the meeting at 7:46 P.M.
